**DECIDES:**

**Article 1.** Appoint Mr. Tran Hong Minh - Acting General Director of Kien Long Commercial Joint Stock Bank, to hold the position of General Director of Kien Long Commercial Joint Stock Bank.

Term of appointment: 5 years, from December 1, 2025 to November 30, 2030.

**Article 3.** Mr. Tran Hong Minh is responsible for performing the rights, obligations and responsibilities according to the Charter, regulations and provisions of Kien Long Commercial Joint Stock Bank, current laws and other tasks assigned by the Board of Directors of Kien Long Commercial Joint Stock Bank.

**Article 4.** Members of the Board of Directors, the Personnel Committee, the Board of Executives, Directors of Divisions, the Regional Directors, the Representative Office Directors, the Heads of Departments, the Head Office Center Directors, Branches, Transaction Offices, all officers, employees, and units under Kien Long Commercial Joint Stock Bank and Mr. Tran Hong Minh are responsible for implementing this Decision.
