3. Activities of the Board of Directors (BOD) in supervising the Executive Board:

BVBank's BOD has assigned specific responsibilities to each member. Each BOD member is tasked with overseeing and supervising specific key areas of the bank's operations, based on their experience, expertise, and capabilities, contributing to enhancing the bank's operational efficiency.

At the same time, to ensure effective supervision and achieve high efficiency throughout the business operation process, the BOD regularly collaborates with the Executive Board and other relevant members to organize regular and ad hoc meetings, specifically as follows:

- Monthly: The BOD participates in a coordination meeting with the Executive Board to promptly address the Executive Board's proposals during BVBank's operations, thereby ensuring the bank's operations are safe and smooth in accordance with the approved development orientation.
- Quarterly: The Board of Directors (BOD) organizes an extended coordination meeting among the BOD, the Board of Supervisors (BOS), the Executive Board, and other relevant members to comprehensively evaluate the bank's operations in the previous quarter. Based on the evaluation, the BOD provides guidance and direction for future tasks and promptly offers opinions, suggestions, and development orientations for the following period.
- Additionally, the BOD organizes extraordinary Board meetings to resolve and handle emerging matters.

The Board of Directors instructed the General Director to implement solutions to rectify, address violations, or amend procedures and regulations to align with actual practices and comply with the State Bank's regulations. In 2024, the Executive Board effectively addressed the internal audit recommendations, contributing to the reduction of risks in BVBank's operations.

In compliance with the Law on Credit Institutions, The Board of Supervisors has monitored the list of founding shareholders, major shareholders, members of the Board of Directors, members of the Board of Supervisors, the General Director and related parties of members of the Board of Directors, members of the Board of Supervisors, and the General Director and has updated the information regularly to ensure that it is complete and timely as required.
