### 3. Supervising the Board of Management by the Board of Directors

Based on the Charter and Internal Regulations on Corporate Governance, the Board of Directors (BOD) has supervised all activities of the General Director and the Executive Board in organizing business operations and implementing the resolutions of the General Meeting of Shareholders and the Board of Directors. Focused on directing the implementation of the 2024 business and investment plan, high-tech agricultural development, digital transformation, sustainable development, and personnel arrangements when the Executive was indicted as required by the legal authorities. This includes personnel management as per regulations,

divesting 30.6% of charter capital in Dak Lak Rubber Investment Joint Stock Company (DRI), and finding solutions to financial difficulties. Business results in 2024 met and exceeded key targets, particularly in revenue and profit.

- Successfully organized the 2024 Annual General Meeting of Shareholders.
- Supplemented, amended, and issued regulations for the Executive Board to implement, including: Regulation on democracy at the workplace; Regulation on the selection of contractors for procurement in business operations and maintenance; Regulation on the organization and operation of the company; Regulation on information disclosure.
- The BOD members, especially the Chairman, scheduled visits to inspect and supervise business activities at the grassroots level, providing timely directives to the Executive Board.
- Each BOD meeting evaluated the implementation results of the Executive Board regarding specific contents of the BOD's resolutions and set directions for the next phase.

Executive Board, led by the General Director, complied well with the directives of the BOD. All matters exceeding the authority defined in the Company's Charter were referred to the BOD for guidance and resolution.
