**HEREBY DECIDES**

**Article 1.** To assign Mr. Phan Thinh, Chief Accountant cum Manager of Finance & Accounting Department, Da Nang Water Supply Joint Stock Company to be Representative of state capital invested in Da Nang Water Supply Joint Stock Company for which the People's Committee of Da Nang City acts as the owner's representative.

Term of appointment of the representative starting from May 1<sup>st</sup> 2025 until the end of current term of The Board of Directors of DaNang Water Supply Joint Stock Company (2021-2026).

**Article 2.** Mr. Phan Thinh is responsible for exercising the rights and fulfilling the obligations of the representative according to the regulations at Regulation on the management of activities of representatives of state capital invested in enterprises for which the People's Committee of Da Nang City acts as the owner's representative and related law regulations.

**Article 3.** This decision takes effect from the date of signing.

**Article 4.** Chief of Office of DaNang People's Committee, Director of Home Affairs Department, Finance Department, Planning & Investment Department, Construction Department, Da Nang Water Supply Joint Stock Company; Heads of the other departments and related person and Mr. Phan Thinh are responsible for the implementation of this Decision./.
