- Pursuant to the provision of Article 14 of Circular No. 96/2020/TT-BTC dated 16 November 2020 issued by the Ministry of Finance guiding information disclosure on the stock market.
- Pursuant to the provision of Article 4 of Circular No. 68/2024/TT-BTC dated September 18, 2024 issued by the Ministry of Finance for disclosing information in both Vietnamese and English.
- Based on profit after tax in the Consolidated Financial Statements of Quarter 3, 2025 of An Binh Commercial Joint Stock Bank (ABBANK).

ABBANK's explanation for the fluctuation of profit after tax in the third quarter and accumulated to the third quarter of 2025, which changed by more than 10% compared to the third quarter and accumulated to the third quarter of 2024, and the profit arising from the quarter changed from loss in the third quarter of 2024 to profit in the third quarter of 2025 specifically as follows:

- (1) The profit after tax of ABBANK, as presented in the consolidated financial statement for quarter 3/2025, reached VND 511 billion. Compared to the same period last year, profit after tax increased by VND 796 billion (a 279% increase), shifting from a loss of VND 285 billion in the third quarter of 2024 to a profit of VND 511 billion in the third quarter of 2025, mainly due to the impact of the following indicators:
 - Net interest and similar income grew VND 877 billion compared to the same period last year, and equivalent to a 119% growth.
 - Net gain from other operating activities increased VND 666 billion compared to the same period last year, and equivalent to a 2,562% increase.
- (2) The profit after tax of ABBANK, which is presented in the consolidated financial statement, accumulated up to the third quarter of 2025, reached VND 1,846 billion. Compared to the same period last year, profit after tax increased by VND 1,665 billion (a 920% increase), mainly due to the impact of the following indicators:
 - Net interest and similar income grew VND 1,188 billion compared to the same period last year, and equivalent to a 54% growth.
 - Net gain from other operating activities increased VND 1,629 billion compared to the same period last year, and equivalent to a 1,253% increase.
