- Pursuant to the provision of Article 14 of Circular No. 96/2020/TT-BTC dated 16 November 2020 issued by the Ministry of Finance guiding information disclosure on the stock market.
- Pursuant to the provision of Article 4 of Circular No. 68/2024/TT-BTC dated September 18, 2024 issued by the Ministry of Finance for disclosing information in both Vietnamese and English.
- Based on profit after tax in the Separate Financial Statements of Quarter 3, 2025 of An Binh Commercial Joint Stock Bank (ABBANK).

ABBANK's explanation for the fluctuation of profit after tax in the third quarter and accumulated to the third quarter of 2025, which changed by more than 10% compared to the third quarter and accumulated to the third quarter of 2024, and the profit arising from the quarter changed from loss in the third quarter of 2024 to profit in the third quarter of 2025 specifically as follows:

- (1) The profit after tax of ABBANK, as presented in the separate financial statement for quarter 3/2025, reached VND 499 billion. Compared to the same period last year, profit after tax increased by VND 744 billion (a 304% increase), shifting from a loss of VND 245 billion in the third quarter of 2024 to a profit of VND 499 billion in the third quarter of 2025, mainly due to the impact of the following indicators:
 - Net interest and similar income grew VND 884 billion compared to the same period last year, and equivalent to a 123% growth.
 - Net gain from other operating activities increased VND 662 billion compared to the same period last year, and equivalent to a 2,207% increase.
- (2) The profit after tax of ABBANK, which is presented in the separate financial statement, accumulated up to the third quarter of 2025, reached VND 1,834 billion. Compared to the same period last year, profit after tax increased by VND 1,633 billion (a 812% increase), mainly due to the impact of the following indicators:
 - Net interest and similar income grew VND 1,190 billion compared to the same period last year, and equivalent to a 55% growth.
 - Net gain from other operating activities increased VND 1,624 billion compared to the same period last year, and equivalent to a 1,212% increase.
