2. Supervising the Board of Management by the Board of Directors:

- Promoted investment in the development of new products, enhancement of equipment, and production lines to meet business growth demands.

 - + Assisting the CEO in external affairs.
 - + Supervising, assisting, and urging the CEO in the Company's general procurement activities, including the purchase of raw materials, goods, supplies, asset investments, machinery, and equipment, etc.


