3. Supervising the Board of Management by the Board of Directors:

In general, the aviation industry in 2024 faced significant challenges due to a decline in domestic flight volume and unpredictable market conditions. International and domestic passenger traffic exhibited contrasting growth trends.

According to data from the 2024 year-end review conference of the Airports Corporation of Vietnam, total passenger traffic reached 109 million, equivalent to 96% of the 2024 target and 97% of 2023 levels. Of which, international passengers numbered 41 million, achieving 98% of the 2024 target and increasing by 26% compared to 2023; Meanwhile, Domestic passengers numbered 68

million, achieving 95% of the 2024 target, but decresing by 15% compared to 2023.

In response to this situation, the Board of Directors (BOD) regularly consulted with the Board of Management on the implementation of business plans and contents approved by the General Meeting of Shareholders (GMS)/BOD. They also applied flexible solutions suitable to market developments, through various flexible means, such as by phone, email, etc., to promptly update information.

Based on the Company's Charter and Corporate Governance Regulations, in addition to defining business orientations and objectives, the BOD conducted inspections and supervised the Board of Management's operations in managing business production and implementing the Resolutions/Decisions issued by the GMS and BOD in 2024.

The BOD discussed and approved contents related to business production plans and personnel plans, issued Resolutions/Decisions to guide the Management in their implementation, and requested the Management to report on implementation results at BOD meetings or ad-hoc reports as needed. At the same time, the BOD also provided timely guidance and direction during the execution of these Resolutions/Decisions.

The BOD monitored the Board of Management's activities by coordinating with the Board of Supervisors to inspect and evaluate reports from the Management and the independent audit firm.
