3. Supervisory activities of the Supervisory Board with the Board of Directors, Management Board and shareholders

3.1 Supervisory activities of the Supervisory Board over the Board of Directors:

The Board of Directors has 05 members, of which 01 member is concurrently the CEO and 04 full-time members; from the beginning of the term on August 13, 2020, to the end of 2024, there has been no change in the members of the Board of Directors. The Board of Directors has operated by the functions, tasks, and powers prescribed in the Law on Enterprises 2020, the Charter, internal regulations on corporate governance of VIMC, and current legal provisions. On April 16, 2024, VIMC held the 2024 Annual General Meeting of Shareholders. The General Meeting of Shareholders issued Resolution No. 229/NQ-ĐHĐCĐ dated April 16, 2024, assigning the Board of Directors and the Corporation's Supervisory Board to implement. The Supervisory Board has adequately performed its responsibilities in supervising the management activities of the Board of Directors through participating in meetings of the Board of Directors, reviewing the Resolutions of the Board of Directors Decisions and Regulations issued by the Board of Directors; the process of inspecting and supervising the General Director in implementing the Resolutions and Decisions.

Continue to promote the effectiveness achieved in 2023 according to Resolution No. 11/NQ-HHVN and determined to comprehensively innovate activities to realize the vision to 2030 - VIMC rises to the number one position in the Vietnamese maritime industry and leaves its mark on the international maritime map , from the beginning of 2024 , the Board of Directors of VIMC met and issued Resolution No. 10/NQ-HHVN dated January 10, 2024 on the 2024 Action Program of the Board of Directors of TCTHHVN with the goal: Continue to implement the contents of the Dai Lai Action Statement and implement the principle of "1 SYSTEM, 2 CENTERS, 3 STRATEGIES " to specify the tasks, continue to achieve Innovate operating methods , proactively adapt , act more decisively and effectively in the spirit of the Government 's management theme "Discipline and responsibility ; Proactive and timely; Accelerating innovation; Sustainable efficiency" taking that as a guideline to deploy direction and organize implementation throughout the year 2024 .

2024, the Board of Directors followed the established production and business plan. Approved by the 2024 General Meeting of Shareholders, directing the Management Board to implement. The Board of Directors is organized to operate in a specialized manner, make collective decisions, and assign tasks to members of the Board of Directors according to each field of operation. The Board of Directors has closely monitored the Management Board's operations based on the results of implementing the set targets and progress. Outlined in Resolution No. 229/NQ -ĐHĐCĐ dated April 16, 2024, and Resolution No. 10/NQ-HHVN in particular, specifically in 4 areas of operation: Financial work; Customer work; Internal processes and Learning and development, periodically organizing a review and assessment of the situation and

setting out directions for the next period to achieve the plan targets assigned by the General Meeting of Shareholders.

Along with the innovation of its operating model, VIMC has Innovating advanced and modern management methods, strongly decentralizing and decentralizing; business management is both centralized and flexible, customer-centric; continuous improvement (Kaizen); recruitment and appointment mechanism through competitive, public, and transparent examinations; attractive salary and bonus policies, attracting talents firmly applying information technology. VIMC's management model is implemented throughout according to the 123 principles:

1 SYSTEM: Build a practical, flexible business system that adapts to change with unified standards and regulations applied to all businesses of the Corporation.

2 CENTERS: (1) Customer-centric; (2) People-centric. This is a consistent task to form a common culture throughout the Corporation.

3 STRATEGIES: (1) Building and developing deep-water ports; (2) Building and developing container fleets and transportation/logistics services on digital technology platforms; (3) Building an effective resource management system.

In 2024, VIMC 's Board of Directors proactively adapted to changes in the business environment and maximized its potential. To improve operational efficiency, VIMC set a key goal of promoting market /market share development , focusing on building foundations in infrastructure , technology , and human resources to develop new markets/customers; proactively following market developments to ensure operational efficiency in terms of revenue and profit; promoting investment and development , mainly focusing resources on key projects in port infrastructure, logistics, and ship investment projects; strongly innovating in corporate governance, applying advanced and modern governance principles according to international practices; firmly applying information technology ; Develop high-quality human resources; strengthen the connection between VIMC's member enterprises to build a comprehensive service chain; proactively integrate and form joint ventures based on the Development Strategy for the period 2021-2030, vision to 2035; production and business plan, investment, and restructuring project of VIMC for the period 2021-2025.

In 2024, the Board of Directors held 05 meetings and many consultations, working with the Corporation's Board of Directors at the member enterprises. The Board of Directors received 219 reports from the Management Board, issued 210 Resolutions and 85 Decisions mainly focusing on debt restructuring and capacity improvement at 02 joint venture ports SSIT, CICT (On November 5, 2024, VIMC completed the transfer of money to buy 51% of CICT's debt at SSA and transferred money to buy 51% of CICT's debt at Lenders on November 12, 2024, VIMC completed the financial restructuring plan at CICT); Restructuring Saigon Port is associated with the exploitation activities of joint venture ports in the direction of container and bulk cargo exploitation; Restructuring and financial control of inefficient enterprises ; investment in projects

of Wharf 3, 4 Lach Huyen at Hai Phong Port, Wharf 1 Quy Nhon Port, speeding up procedures for implementing deep- water port projects in Can Gio, Lien Chieu; amending and enhancing the effectiveness of internal regulations; personnel work; purchasing and liquidating assets, contents for the Board of Directors at units with contributed capital to vote at the General Meeting of Shareholders. Up to the time of reporting, there are 06 resolutions issued by the Board of Directors that are still in the process of implementation, specifically:

(1) Resolution No. 345/NQ-HHVN, dated September 24, 2021, has been completed on the Action Program to implement VIMC's Digital Transformation Strategy for 2021-2025 with a vision to 2030 of VIMC's Board of Directors. 80% of the project has been completed.

(2) Resolution No. 283/NQ-HHVN dated May 14, 2024, on the Capital Transfer Plan of the Corporation at Vietnam Container Exploitation Company Limited.

(3) Resolution No. 323/NQ-HHVN, dated June 7, 2024, on Development Strategy for the period 2021-2030, Vision 2035; Production and business plan and Investment for the period 2021-2025, the Corporation is implementing according to the Annual Plan.

(4) Resolution No. 411/NQ-HHVN dated August 28, 2024, on the Plan to organize activities to celebrate the 30th anniversary of the establishment of Vietnam Maritime Corporation (April 29, 1995 - April 29, 2025). No. 1580/TB-HHVN dated September 30, 2024, on the notice of invitation for bids for providing consulting services for activities to celebrate the 30th anniversary of the establishment of Vietnam Maritime Corporation.

(5) Resolution No. 431/NQ-HHVN dated September 13, 202,4, on Authorization to approve the final settlement of the project to complete the project "Building a new 12,500 DWT Vinalines Freedom dry cargo ship, No. 1/KH2006 (Code HL15)" has been issued. Resolution No. 245/QD -HHVN dated September 25, 2024, on establishing the Council to review and approve the final settlement of the project to complete the HL15 ship project.

(6) Resolution No. 559/NQ-HHVN dated December 27, 2024, on the 2025 production, business, and investment development plan of Vietnam Maritime Corporation - JSC.

Regarding Resolution No. 229/NQ - ĐHĐCĐ dated April 16, 2024, on the content of Investment in capital contribution to establish a joint venture company between Vietnam Maritime Corporation and Aries Energy Corporation - Greece, the Board of Directors issued Resolution No. 471/NQ-HHVN dated October 17, 2024 on the Policy on personnel work of VIMC - ARIES Maritime Services Joint Venture Company Limited. As of November 6, 2024, the personnel work at VASC Company has been completed. However, Resolution No. 402/NQ-HHVN dated August 9, 2024, the establishment of the Joint Venture between VIMC and Aries is currently not completed because the documents required by the Department of Planning and Investment, Aries have not been completed.

In 2024, the members of the Board of Directors proactively performed their duties and completed their assigned tasks. Being assigned, fully participating, and having voting opinions on

issues under their authority, each member of the Board of Directors has coordinated well in the leadership, direction, and operation of the Corporation, creating high consensus and unity within the Board of Directors for decisions on policies, strategies, orientations and essential tasks of the Corporation.

3.2 Supervisory activities of the Supervisory Board over the Management Board:

The Management Board comprises 04 members, including 01 General Director and 03 Deputy General Directors. The Management Board promptly issued Decision No. 02 /QD - HHVN dated January 2, 2024, on the assignment of tasks between the General Director and Deputy General Directors (01 Deputy General Director in charge of internal affairs and investment; 01 Deputy General Director in charge of management, exploitation of maritime transport and legal fields, risk management; 01 Deputy General Director in charge of market development and brand development communication). The Supervisory Board supervises the Management Board by overseeing the Management Board in organizing the 2024 production and business plan implementation. Approved by the 2024 General Meeting of Shareholders, Resolution No. 10/NQ-HHVN dated January 10, 2024 of the Board of Directors. The supervision of the Management Board is carried out regularly, specifically at the meetings, participating in the meetings of the Management Board with member units. The Management Board has promptly proposed measures to remove difficulties and bottlenecks in production and business activities to strive to complete the assigned plan. The Management Board has thoughtfully implemented the Resolutions /Decisions of the Board of Directors and directed relevant departments to implement them fully. The Management Board has complied with the direction of the Board of Directors, internal regulations, rules, the Corporation's Charter, and current legal provisions.

3.3 For shareholders:

VIMC has done a good job of disclosing information to shareholders, partners, and interested parties fully, promptly, and by the provisions of Securities Law No. 54/2019/QH14, Circular No. 96/2020/TT-BTC dated November 16, 2020, on guidelines for information disclosure on the stock market, and other relevant documents.

The Supervisory Board received no letters or recommendations from shareholders regarding the corporation's general operations.

4. Coordination of activities between the Supervisory Board and the activities of the Board of Directors, the Management Board, and other management staff

The Board of Directors and CEO have created favorable conditions for the Supervisory Board to fulfill their tasks. The Supervisory Board has been provided with complete information and documents related to the activities of the Board of Directors and invited to attend all meetings of the Board of Directors monthly and quarterly sessions and some other necessary meetings of the Management Board; thereby, the Supervisory Board has grasped the information and been more closely involved in supervising the activities of VIMC, the opinions and contributions of the Supervisory Board to the activities of VIMC have been recorded and adjusted immediately in the management and operation decisions of VIMC.

The Board of Directors coordinates with the VIMC Supervisory Board to strengthen the implementation of the functions of supervision, management, and direction in implementing the objectives set forth by the General Meeting of Shareholders in compliance with the provisions of law and the VIMC Charter. The Board of Directors closely coordinates with the VIMC Supervisory Board as a representative supervisor for shareholders.

The Management Board always receives and implements necessary solutions in corporate governance according to the direction of the Board of Directors and the proposals of the Supervisory Board.

The VIMC Supervisory Board regularly and closely supervises the activities of the Board of Directors and the Management Board, ensuring that VIMC 's activities are carried out by the Resolutions of the General Meeting of Shareholders and the resolutions/decisions of the Board of Directors and always act in the interests of VIMC shareholders.5.
