2. BOD meetings

In the first 6 months of 2025, the BOD conducted BOD meetings to pass resolutions, to direct, to instruct on the agenda of NCB over time; to review and decide on the articles within the BOD's authority (Appendix 1).

3. Supervision of the BOD on the activities of BOM

The supervision of the BOD, under which the BOM is placed, is conducted in accordance with NCB's regulation of internal control, specifically:

- The BOD may convene with the BOM for monthly progress meetings, mid-year performance reviews, annual performance reviews, or to discuss thematic topics. The BOM reports to the BOD on: the implementation progress of the Resolutions and Decision made by the AGM or BOD; the progress of business operation in previous periods, and the implementation plan for the next preiod; specific topics upon BOD's requests. At these meetings, the BOD may analyse, evaluate, and provide BOM with instructions to correctly implement business plan and achieve assigned targets.
- The BOD supervised and instructed BOM on all aspects of NCB's operation in accordance with the orientation, targets, strategy; the BOM closely followed such targets, direction, and thoroughly completed the tasks assigned by AGM and BOD.

4. Operations of the Committees within BOD:

NCB currently has 05 Committees/Councils, including: Human Resource Committee (hereinafter referred to as "HRC"), Risk Management Committee (hereinafter referred to as "RMC"), Credit Committee, Technology Committee, and Risk Settlement Council (hereinafter referred to as "RSC"). The establishments of these Committees and Councils are compliant to the

laws and regulations. The Committees operate in accordance with the respective Regulation on organization and operation issued by the BOD, in which:

(i) Human Resource Committee:

The HRC is composed of 3 members. With the function of providing advices, counselling to the BOD on the organisational structure, human resource system and policies throughout the BOD's term, in the first 6 months of 2025, HRC has organized 8 in-person meeting and collected written opinions (23 times), and counsel, advise the BOD on the following articles:

- Recruitment plans, renewal of labor contracts, termination of labor contracts, and appointment of personnel for key positions;
- Review and improvement of the organizational structure and human resources across the entire system;
- Adjustment and refinement of the Bank's job title system;
- Evaluation and classification of 2024 work performance, compensation policies, bonus fund formation plan, performance-based bonus distribution plan, and bonus distribution programs;
- Salary adjustment plan for 2025;
- Compensation framework for the 2025-2027 period;
- Adjustment of internal staff lending policies.

(ii) Technology Committee:

The Technology Committee is tasked with counsel ing BOD on technological development direction, technological applications serving the strengthening of management capabilities, enhancing business performance of NCB. In the first 6 months of 2025, the Technology Committee organised 02 quarterly meetings as requested by the President of Technology Committee, and advised, counselled the BOD on the following articles:

- Review and improve NCB's system of documents/regulations/procedures on information security, ensuring compliance with legal regulations and the Bank's practical requirements;
- Proposal to support resource enhancement and encourage accelerated implementation of the Casa War Room project in 2025;
- Organize implementation and supervise the execution of Digital Transformation projects and Information Technology projects.

(iii) Credit Committee:

The Credit Committee review, evaluate, advise, and submit proposal for BOD's approval of credit extension within BOD authority. In the first 6 months of 2025, the Credit Committee organised meetings, and submit proposals to the BOD for the apporvals of vaious credit extensions / adjustment of credit extensions within BOD's authority.¹

¹ In the first half of 2025, the Credit Committee advised and submitted to the BOD for consideration and approval a total of 88 credit applications under the BOD's authority.

(iv) Risk Management Committee:

Tasked with advising the BOD on risk management, in the first 6 months of 2025, the RMC organised 02 meetings, and collected written opinion on the following articles:

- Advised the Board of Directors on issuing the risk appetite for the 2025–2027 period and monitored its implementation;
- Reviewed and provided opinions on the report and proposed capital stress testing scenarios and capital planning;
- Evaluated and commented on the strengthening of compliance control and supervision at the Bank;
- Evaluated and commented on the development of NCB's internal credit rating system;
- Oversaw the implementation of minor projects aimed at enhancing risk management capabilities and improving the internal control system at NCB;
- Monitored the implementation of risk appetite and risk limits; directed the review and refinement of the risk limit framework.

(v) Risk Settlement Council:

The Risk Settlement Council held meetings to review and approve debt classification, risk provisioning, debt resolution plans, collateral handling, and legal actions against customers within its authority. The Council also advised and submitted risk handling plans to the Board of Directors for approval when required. In the first 6 months of 2025, the Council reviewed and provided opinions on 82 risk handling dossiers/plans, including 19 cases submitted to the BOD for approval.

3. Supervision of the SB on the activities of BOD, BOM, and shareholders

- In 2024, the SB has supervised the compliance in accordance with the laws, internal regulations, NCB's charter, Resolutions, Decisions of the AGM, BOD in management and operations:
 - + Monitor BOD in the implementation of AGM's Resolutions, Decisions; implementation of directions and business targets approved by the irregular AGM on 18/11/2023; and the regular AGM on 13/4/2024.
 - + Monitor the CEO's implementation of BOD's instructions, resolutions, decisions.
 - + Monitor the timely implementation of the government and SBV's directives and policies of BOD and CEO.
- Representative of the SB participated in BOD and BOM meetings in accordance with regulations.
- Monitor the implementation of enhanced surveilance regulation and instruct Internal Audit Centre (hereinafter referred to as "IAC") in reviewing credit extension valued at least 50 billions VND. The IAC is the point of contact for capital contribution, purchase of shares; payable amounts for transactions in the form of capital contribution, purchase of shares for the purpose of attaining corporate control valued at least 50 billion VND.
- Monitor change result in accordance with recommendations of the Inspection Conclusion.
- Monitor the implementation progress of the Restructuring Solution.
- SB draft quarterly supervisory report, risk report of NCB's business operation to BOD, BOM. SB oversaw NCB financial situation, closely monitored information announcement, especially the announcement regulations on regular financial report and management report on the stock market of listed firms.
- SB monitored limitation compliance to ensure NCB operational security in accordance with the Law on Credit institution.
- SB monitored the approval and implementation of investment, purchase, sales of fixed assets; other NCB contract, transaction within AGM, BOD authority. The SB also drafted and sent evaluation, recommendation report on the aforementioned articles to the BOD and AGM at the earliest available assembly.
- By conducting other works in accordance with the Law on Creditt institution, Corporate Law, SB monitored the update of founding shareholders list within 5 years of participation as a founding shareholders, shareholders who own at least 1% of the Charter capital, related people of BOD members, SB member, CEO, and shareholders who own at least 1% of the Charter capital.

4. Coordination between SB and the operation of BOD, BOM, and other managers

In the first half of 2025, the SB conducted the following activities:

- Proposed and recommended to the AGM the approval of the independent audit firm to audit/review NCB's 2026 financial statements and internal control system.
- Appraised the 2024 financial statements, evaluating the legality, accuracy, and prudence of accounting, statistics, and financial reporting practices.
- Directed the IAC to perform duties in accordance with NCB's Charter, SB regulations, and the 2025 internal audit plan.
- Oversaw the IAC in conducting 5 audits of business units and 8 thematic audits across various departments/branches, including topics such as AML, international payments, and loan under enhanced surveillance...
- Monitored the implementation of recommendations by the SB and internal auditors.
- Continued sub-projects to enhance internal audit capacity based on an independent review and roadmap to improve NCB's internal control system.
- Collaborated with KPMG during the final stage of the audit project assessing senior management supervision at NCB.
- Directed the IAC to coordinate with relevant units in preparing reports for the SBV, governance reports, and the annual report.

VI. Training on corporate governance:

Corporate governance training courses attended by members of the Board of Directors, members of the Supervisory Board, the CEO, other executive managers, and the Corporate Secretary in accordance with corporate governance regulations:

In the first six months of 2025, National Citizen Commercial Joint Stock Bank (NCB) organized multiple training programs aimed at enhancing the knowledge and skills of its leadership team, including Board members, Supervisory Board members, Executive Board, and management personnel at both Head Office and Business Units. Key training topics included:

- 1. Compliance and Risk Management:
- Overview of Fraud Risk Management: Organized by the Risk Management Division, this course covered key points to be mindful of during operations.
- Anti-Money Laundering (AML): Targeted at both managers and staff, this training provided an overview of legal regulations and common signs of customer-related money laundering activities.
- Tax Operations and Policy 2025: Provided consultation and clarification on changes in tax laws.
- 2. Training on Information Technology and Digital Transformation:
- Effective Leadership in the Age of AI: A specialized program designed for senior management, updating them on AI trends in finance and banking and how to use AI tools in management.
- Digital Transformation Mindset for Managers: Covered current digital transformation trends, transformation processes in financial institutions, customer behavior shifts, and hands-on use of AI tools for work purposes.
- Advanced IT Training Courses: Included topics such as Basic and Advanced SQL, and Data Analysis & Visualization using Looker Studio.
- 3. Branch Directors participated in training sessions on products, processes, and operations to strengthen their expertise and improve their ability to manage and support sales staff.

4. At NCB, in addition to technical and skills training, knowledge-sharing sessions between senior leadership and management/staff are regularly held. In the first half of 2025, NCB organized two "Leader Talk" sessions under the theme "Digital Culture on the Transformation Journey." These sessions focused on building a digital culture at NCB – considered a key factor for success in the new phase. During the sessions, managers discussed and shared views on core values that need to be cultivated and activities that help foster a united, dynamic, and creative working environment.
