3. Supervisory activities of the BOD over the Board of Management

Based on the Resolutions of the General Meeting of Shareholders and within its authority, the BOD has approved and assigned the Board of Management to implement. The BOD's evaluation of the Board of Management focused on the following areas:

3.1 Supervision of organizational structure

The Company maintains its organizational model in compliance with the Law on Enterprises and the Company's Charter.

The Company identifies the supervision of the organizational structure as a key task in the BOD's supervision of the Board of Management, directly related to the organizational apparatus, operational management, and the Company's efficiency. Given the specific nature of the Company's business, at the request of the Board of Management, the BOD approves the Company's organizational system and assigns responsibilities to the General Director, Deputy General Directors, Directors and Deputy Directors of enterprises, and Heads/Deputy Heads of departments based on maximizing the capacity, intellect, and responsibility of individual leaders in performing their duties, enhancing smooth coordination and mutual support in the performance of their responsibilities.

3.2 Supervision of production and business operations (PBO)

Regularly inspect and evaluate the Company's monthly and quarterly business performance. In addition, the Chairman of the Board of Directors and the Company's Board of General Directors, along with the heads and deputy heads of the Company's departments, attend bi-monthly meetings to evaluate and monitor the implementation of business performance tasks and professional duties of the Company's departments and grassroots units, while also resolving difficulties arising in the Company's operational activities; identifying subjective and objective factors to promptly implement appropriate corrective measures.

The BOD, especially the Chairman, always directly and closely directs each department and enterprise, thereby promptly resolving difficulties arising in the Company's operations. In the first 6 months of the year, the Company developed a specific work program with affiliated units (according to the periodic work plan of twice a year) and organized preliminary meetings and thematic briefings to

evaluate the implementation of production and business tasks to promptly propose solutions and measures to boost operational efficiency.

The supervision results show that the Board of Management has aggressively implemented production and business activities and measures to cope with difficult situations, which were applied timely and effectively.

In the first 6 months of 2026, the Company effectively implemented several key work areas, such as: strengthening the application of selling prices for electricity and water customers in accordance with regulated prices; controlling electricity purchase costs; and supervising the operation and management of electricity and water to save production costs, etc.

In addition, the Company has promoted the application of information technology in its production and business activities, such as: recording and sending the first electricity and water bill notices (completed in over 05 units); and online water quality control at a number of major water supply systems.

Promoting production and business in the field of bottled water, maintenance and repair of industrial electrical systems, and construction of several public lighting projects.

3.3 Other supervisory activities

- Supervision of operational implementation: The Chairman of the BOD and the General Director have assigned tasks to the system of company departments and enterprises to organize meetings with relevant departments to resolve issues within their authority, as well as to promptly seek guidance from the BOD on major issues in the Company's operations.

- Fulfilling obligations to pay the state budget; paying salaries to employees on time and in accordance with regulations.

- Maintaining solidarity and consensus throughout the Company: there are no internal conflicts within the Company.

In the first 6 months of 2026, the BOD performed its supervisory duties cautiously in accordance with the Company's Charter and internal regulations on corporate governance, in compliance with the law, bringing the highest efficiency and benefits to the Company and its shareholders. Through supervision, the BOD assesses that the Board of Management has managed the company's operations with significant effort and has achieved encouraging results. During the management process, the Board of Management has strictly complied with the provisions of the law, the Charter, and the Company's internal governance regulations.

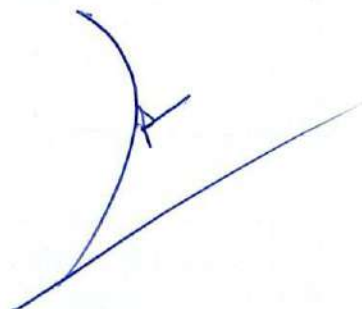

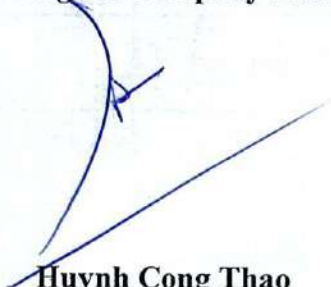

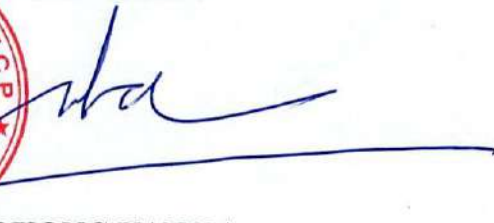
