In the first six months of 2025, the revenue after CIT decreased around 48 billion Dong compared to the same period last year, mainly because of the decline in the gross profit from goods sold and services rendered. Furthermore, the income from financial activities decreased as in 2024, SII earned dividends from Tan Hiep Company, not only because of the divestment of long-term investments -Thu Duc Water B.O.O Corporation, resulting in a loss recorded in the provision account has led to an increase in financial expenses. Moreover, the selling expenses increased compared to the same period last year, primarily due to the reorganization of personnel between the sales department and the management department.

The revenue after CIT in the first 6 months of 2025 witnessed a loss of 23.351.779.166 Dong due to revenues and income failing to balance the expenses during the period, and the output of the Cu Chi project is not meeting expectations. Additionally, the loan for the Cu Chi Project was excessive, causing increased financial costs, as detailed below:
