The directed contents include the development of plans and the implementation of production-business plan targets for 2024, such as: rubber latex exploitation output, latex processing, sales, replanting and new planting, garden care, arrangement of latex tapping labor, latex protection in gardens, environmental work, etc.

The Chairman and members participate in monthly meetings convened by the General Director. Implementing the policy on investment in high-tech agricultural production projects in the locality, the People's Committee of BRVT Province issued Decision No. 2236/QĐ-UBND dated August 29, 2019, and Decision 2241A/QĐ-UBND dated August 29, 2019, on the recovery of 326.61 hectares of land (of which: Xuan Son Commune People's Committee manages 2.69 hectares of land, Ba Ria Rubber Joint

Stock Company manages 323.92 hectares of land) with a compensation value of 45.6 billion VND for 323.92 hectares. In 2023, 47.4 hectares of land were handed over for the exploitation of leveling materials for the Bien Hoa - Vung Tau Expressway Phase 1, following Resolution No. 90/NQ-CP of the government and Decision No. 1063/QĐ-UBND dated May 10, 2023, of Ba Ria - Vung Tau Province.

The remaining area has not yet completed the handover procedures because Ba Ria Rubber Joint Stock Company and the People's Committee of Ba Ria - Vung Tau Province have not agreed on the compensation and support price. Ba Ria Rubber Joint Stock Company has repeatedly sent written requests to soon reach an agreement on the handover, but to date, the handover of the above land area has not been completed. The Company continues to accelerate the progress to reach an agreement on the compensation price and carry out land handover procedures according to regulations.
