#### 3. Supervising the Board of Management by the Board of Directors

In 2024, the Company's Board of Directors (BOD) operated in compliance with the provisions of the Enterprise Law and relevant legal regulations. The BOD directed the Board of Management to review existing regulations and develop several new policies for submission to the BOD for approval and implementation, ensuring alignment with legal provisions and TKV's guidelines. In 2024, the General Director submitted to the BOD for approval various content of strengthening the company's management in financial aspect, etc. In the Company's production and business activities, the Party Committee, Trade Union, and Executive Director signed the joint resolutions to unify executive leadership in movement activities of employees and workers of the Company. Through supervisory activity, the BOD assessed that:

- The Board of Management of the Company has fully implemented the Resolutions and Decisions of the Board of Directors; the Regulations and Rules of the Vietnam National Coal Mineral Industries Group and related legal provisions. During the task performing process, the Board of Management submitted to the Board of Directors to reorganize the organizational model and reissue regulations in accordance with State regulations.
- Regarding cost management: The Company has closely controlled the allocation and management of costs to workshops to strengthen management, strictly control the daily cost and improve the efficiency of mobilizing and utilizing machinery and equipment.
- Investment in construction: The Company has focused on key and prioritized investment projects to save costs and enhance investment efficiency. The construction investment activities of the Company have been carried out in compliance with legal regulations, guidelines from the Vietnam National Coal Mineral Industries Group, and the Company's Investment Management Regulations.
- Security and order: The Company has developed plans and measures for self-managed security, installed cameras at multiple locations to monitor coal storage areas and mining site entries and exits. Additionally, the Company has strengthened the protection of mine boundaries, prevented illegal coal mining, processing, and transportation, increased patrols, and coordinated with local police forces to protect the Company's assets.

- In 2024, the Board of Management managed the Company's production and business activities and other operations in compliance with the law, the directives of TKV

Group, and the Resolutions and Decisions of the Board of Directors. As a result, the Company successfully achieved the main targets outlined in the business cooperation contract with TKV Group and fully fulfilled its obligations to contribute to the State budget.

- The production management process was flexible, with regular reports submitted to the Board of Directors on arising issues and timely resolutions for matters under the Board's authority. Consequently, all production and business activities of the Company proceeded smoothly without disruptions. The company met the key targets of its 2024 production and business plan. After making provisions and purchasing property insurance as required, the company achieved a pre-tax profit of 65 billion VND, thereby preserving and growing its capital.
