### 3. Supervising the Board of Management by the Board of Directors:

In 2024, the Board of Directors held 4 meetings and approved several matters presented by the General Director. All Board meetings were attended by members of the Supervisory Board passed several key resolutions for PC3-INVEST's operations, including: approving the 2023 performance evaluation results for the Vice General Director, Chief Accountant, and Heads and Deputy Heads of departments; issuing the company's 2024 risk management plan; finalizing the record date and the time for the 2024 Annual General Meeting of Shareholders; approving the 2023 final settlement of the total salary and remuneration fund; appointing the Company's Chief Accountant; approving the policy to establish a supplementary guarantee deposit for the Đăk Pône hydropower plant project; approving the 2024 planned salary and remuneration fund; dismissing Mr. Nguyễn Durong Long from his position as Vice General Director; deciding on the payment plan for the remaining 2023 dividends by cash; reappointment of the branch manager in Kon Tum; approval of the major repair plan for the Đăk Pône hydropower plant in 2025; reappointment of the head of the Administration-Human Resources Department, the head of the Planning-Investment Department, and the head

of the Project Management Board; approval of the 2024 performance evaluation and classification results for the Vice General Director, the company's Chief Accountant, and the Heads and Deputy Heads of the company's departments; provisional allocation of operating expenses for the 2025 plan; approval of staff planning for the positions of Heads and Deputy Heads of departments under the 2021–2026 and 2026–2031 terms of PC3 Investment Joint Stock Company; selection of a financial institution to provide commercial loans for the investment and construction of the Đăk Pône hydropower plant project (upgrading the A Lake's dam and constructing the B Lake hydropower plant) in Kon Tum province and other matters within the authority of the BOD.

The BOD has supervised the management and operation of PC3-INVEST by the General director and has found that the Executive Board has fulfilled its assigned responsibilities in accordance with the Charter of PC3-INVEST, ensuring that the activities of PC3-INVEST comply with legal regulations, as follows:

- Regarding investment and construction activities
- i). Đăk Pône hydropower plant project (upgrading the A Lake's dam and constructing the B Lake hydropower plant)

Construction of the B Lake hydropower plant

- The compensation and land clearance work has been completed, and the Kon Tum Provincial People's Committee issued the Land Use Right Certificate on July 25<sup>th</sup>, 2024, for the remaining land of the pressure pipeline, the plant, the discharge channel, and the step-up transformer station. The compensation and site clearance for the land required for the 22kV transmission line (the final land portion of the project) are currently underway.
- The project has conducted e-bidding and signed contracts for the remaining five packages as follows: (1) PC3I-DakPone-G02: Procurement of materials and equipment and construction of the 22kV/0.4kV transmission line and substation to supply electricity for construction; (2) PC3I-DakPone-G04: Procurement and installation of hydraulic mechanical equipment, electrical equipment inside the plant, and the 22kV step-up substation; (3) PC3I-DakPone-G11: Insurance for the B Lake hydropower plant; (4) PC3I-DakPone-G12: Audit of the final settlement of the completed project's investment capital and (5) PC3I-DakPone-G14: Supervision of construction and installation of equipment for the B Lake hydropower plant.
- The procedures for agreements with Central Power Corporation (EVNCPC) have been completed: (1) Agreement on the telecommunications and SCADA system of the B Lake hydropower plant connecting to the Kon Tum Power Control Center; (2) Agreement documents on the design of connection works for the B Lake hydropower plant; and (3) Agreement on the technical design of the metering system and data collection system for the B Lake hydropower plant.
- Construction and equipment manufacturing work: Preparation was completed, construction began on May 14<sup>th</sup>, 2024. Up to now, the contractor has completed 70% of the excavation work; the concrete work for the intake structure and the foundation of the pressure pipeline in phase 1 (May 2024) has been finished; fabrication of the pressure

pipeline, gantry crane, and main equipment (turbine-generator) has been completed. Currently, the contractors continue to fabricate the remaining equipment according to the contract schedule and carry out excavation work for the land allocation in phase 2 (July 2024). The construction progress is in line with the contract schedule.

### ii). PC3-INVEST office headquarter project

- The project has conducted e-bidding and signed contracts for the remaining nine packages as follows: (1) PC3I-TSLV-G03: Supply of materials and completion of construction work; (2) PC3I-TSLV-G04: Supply and installation of the elevator system; (3) PC3I-TSLV-G05: Supply and installation of office equipment; (4) PC3I-TSLV-G06: Supply and installation of the meeting and video conferencing equipment system; (5) PC3I-TSLV-G08: Supply and installation of the air conditioning system; (6) PC3I-TSLV-G09: Supervision of construction work; (7) PC3I-TSLV-G10: Insurance for the project; (8) PC3I-TSLV-G07: Supply and installation of backup generators; (9) PC3I-TSLV-G11: Audit of the final settlement of the project investment capital.
- Construction work: Preparations have been completed, and construction commenced on June 7<sup>th</sup>, 2024. Until now, the contractor has completed the pile foundation, basement, and floors. Currently, the contractor is preparing for wall construction and finishing work. Overall, the construction progress is in line with the contract schedule.
- Regarding Business Operations: In 2024, the electricity output was 93.49 million kWh, achieving 101.44% of the plan; total revenue was 121.89 billion VND, reaching 103.55% of the plan; net profit after tax was 32.04 billion VND, reaching 114.20% of the plan set by the 2024 Annual General Meeting (28.056 billion VND).

PC3-INVEST has effectively implemented management activities such as continuing to strengthen the quality management system according to ISO 9001, executing corporate culture, and applying the 5S standard in the production process; cost-saving measures; and actively maintaining hydropower plants based on Risk-Based Management (RBM) methodology. As a result, PC3-INVEST's operations have been strengthened, ensuring absolute safety in occupational health and safety and compliance with legal regulations in business operations and construction investment.
