### I. The activities of the General Meeting of Shareholders

Annual General Meeting of Shareholders 2024 of Safoco Foodstuff Joint Stock Company was held on April 10, 2024. The meeting approved the results of the business operations for the year 2023, the plan for 2024, and several other matters in accordance with the current legal regulations.

The Shareholders' General Meeting dismissed Mr. Nguyen Van Hien and Mr. Nguyen Tri Nghia from their positions as members of the Board of Directors and elected Mr. Ngo Si Tuan Phuong and Mr. Nguyen Quang Tam as new members of the Board of Directors. The Board of Directors then convened and elected Mr. Ngo Si Tuan Phuong as the Chairman of the Board of Directors, a full-time position.

#### 3. Supervising the Board of Management by the Board of Directors

Based on the Charter and internal regulations on corporate governance, the Board of Directors has inspected and supervised the activities of the Board of Management as follows:

- Closely monitored, promptly directed, and decisively managed the Board of Management's activities in implementing the resolutions of the 2024 Annual General Meeting of Shareholders.
- Monitored business performance through periodic meetings and reports from the Board of Management; regularly supervised the implementation of the business plan during the period to provide promptly direction.
- Supervised the disclosure of periodic and extraordinary information in accordance with legal regulations.
- Supervised the Board of Management's activities by requesting clarification/explanation of matters before deciding on issues within the Board of Directors' authority in accordance with the law and the company's internal regulations.

The Board of Directors discussed and approved the contents presented in the meeting through resolutions to provide a basis for implementation by the Board of Management.

The Board of Directors' direction, inspection, and supervision of the Board of Management are in accordance with the authority and responsibilities stipulated in the Enterprise Law, the Charter, and the company's internal regulations.

Through inspection and supervision, the Board of Directors promptly grasped the situation and results of production and business activities, providing timely direction to minimize risks. The Board of Managements has properly performed its assigned functions and duties, striving to manage production and business activities to overcome difficulties, bringing efficiency to the company, and complying with legal regulations, the Charter, and the company's regulations.

#### 4. Activities of the Board of Directors' subcommittees:

The Internal Audit Board is a specialized agency under the Board of Directors of the Company, where the content and scope of internal audit include the following tasks:

- Provide assurance through the examination and evaluation of the adequacy and effectiveness of governance, risk management, and internal control to help the company achieve its strategic, operational, compliance, and financial objectives.
- Provide in-depth analyses and recommendations based on the evaluation of company data and processes.
- Provide objective and independent advice and recommendations: carry out consulting activities related to governance processes, risk management, and internal control appropriate for the company.
- Advise the company on the selection and control of the use of independent audit services to ensure economy and efficiency.
- Inspect and evaluate specific activities as requested by the Board of Management and the Board of Directors.

In 2024, the Internal Audit Board carried out the following tasks:

- Audited and appraised the quarterly, semi-annual, and annual financial statements of 2024.
- Reviewed the status of debts, receivables, and payables of external and internal partners of the company.
- Reviewed the operating results in 2024, including but not limited to revenue, expenses, and profit.
- Inspected the status of production and business activities, reviewed the difficulties and advantages of the export and domestic markets.
- Reviewed the organization of labor, salary and bonus regimes, ensuring stable income and compliance with the labor agreement signed with employees.
  - Reviewed the inventory status within the company and at points of sale.
- Participated in providing comments on building business plan orientations and analyzing market segments such as retail outlets, agents, and supermarket systems by region.
- Propose remedial measures for accounting errors, recommend handling violations, and monitor the rectification of identified shortcomings.

The Internal Audit Board's audit activities are primarily conducted using a "risk-oriented" approach, prioritizing resources to audit departments and processes assessed as high risk.

#### **Internal Audit Results:**

- The Company has prepared and presented financial statements in compliance with Vietnamese Accounting Standards, corporate accounting regulations, and current legal regulations related to financial statement preparation and presentation.
- Agreeing with the independent auditor's conclusion (AASC Auditing Firm Company Limited), the review and audit of the semi-annual and year-end 2024 financial statements were fully accepted by the auditing firm, with no exceptions or recommendations.
- During the year, there were no changes in accounting policies, accounting standards, or tax policies that impacted the financial situation and published financial statements.
- No material errors or inconsistencies were detected that misrepresented the report.
  - Regarding operational management:
- + The Company has implemented a comprehensive management system, including monitoring, evaluation, training, and clear human resources policies, to ensure compliance with laws, regulations, and ethical standards while maintaining a safe, healthy, and fair work environment. Commitment to high business ethics and implementation of security measures to protect customer information.
- + Regularly review and fulfill financial obligations to the State, employees, and other requirements according to legal regulations, effectively manage risks, identify risks, propose response measures, organize monitoring, and report effectively.

The Internal Audit Board recommends the following to the Executive Board:

- Continue to maintain and preserve the existing sales market, constantly develop the sales team in both quantity and quality, and expand the domestic and international sales network.
- Periodically review and assess potential risks to improve the risk management process for the Company's operations.
- Continue to strengthen cost and cash flow control, and apply information technology to management to enhance production and business activities.
  - Remain steadfast in the goal of safe and effective development.
- Continue to enhance the role of Internal Audit in financial control, operational control, and compliance control within the Company's management system.
