- 3.1. Results of Supervision over the Activities of Members of the Board of Directors and the General Director Board

3.1.1. Results of Supervision over the Activities of the Board of Directors

The Board of Directors consists of 07 members, of which 03 members concurrently hold positions in the Company's Executive Board:

- The Board of Directors held quarterly meetings, implementing the Resolution of the General Meeting of Shareholders dated April 16, 2024, to reach a consensus on development orientation, the 2024 production and business plan, and to direct management tasks within the Board's authority. To resolve matters within its competence as prescribed by law and the Company's Charter; The Supervisory Board assesses that the Board of Directors' activities have met the production and business operational requirements of the entire company in a timely manner.
- The Board of Directors obtains opinions in writing to make decisions, meeting the production and business operational requirements promptly. Each meeting is comprehensively summarized with opinions, recorded in minutes, and stored at the company.
- The Board of Directors closely monitors the Company's actual situation, developing appropriate strategies and plans for each business period, managing, supervising, and supporting the Executive Board's operations.
- Resolutions and decisions at Board of Directors meetings are issued based on the high consensus of the Board members.
- The Board of Directors and the Board of Management always coordinate closely, implementing the management-administration relationship in accordance with the Charter and Internal regulations.
- The Board of Directors has agreed to select A&C Auditing and Consulting Co., Ltd. as the auditor for the Company's 2024 financial statements.

- The Board of Directors has issued decisions to strengthen corporate governance, such as: Decision on the appointment of Chief Accountant of Sonadezi Environment Joint Stock Company; Decision on the issuance of Information Disclosure Regulations; Decision on the planning of leadership positions for the period 2020-2025 and 2025-2030.

3.1.2. Results of monitoring the Executive Board's activities

The Company's Executive Board consists of 03 members. The General Director has assigned specific tasks within the Executive Board, and each member has high responsibility for their assigned work.

- The Executive Board has strengthened management and implemented measures to collect and handle debts, limiting capital appropriation that affects capital balance and cash flow for production and business activities.
- The Executive Board has continued to regularly review investment projects to ensure their safe, quality implementation, in accordance with the approved schedule.
- The Executive Board has worked regularly with affiliated units to promptly adjust production and business activities according to the general direction, promptly resolving difficulties and obstacles in production, business, and investment of each department.
