### 3. Supervisory activities of the BOD over the Board of Management:

Pursuant to Vinafor's Charter and the Internal Regulations on Corporate Governance, the BOD has supervised General Director (GD) and the Board of Management's performance in executing the resolutions passed by the General Meeting of Shareholders and the BOD during the year 2024, as detailed below:

- \* Supervisory methods:
- On a monthly basis, the Board members attend the meetings of the Board of Management (BOM) and Departments to stay informed about the operational and

business performance, as well as emerging issues.

- The BOD exchanges opinions and questions the activities of the General Director (GD)/the members of the Board of Management regarding the implementation of the business plan, and the strategic objectives approved by the General Meeting of Shareholders. On a monthly basis, GD reports to the BOD on the progress of the business plan. The BOD and GD shall discuss and exchange views during the monthly Board meetings and through one-on-one meetings to identify and resolve difficulties, ensuring the achievement of the goals set by the General Meeting of Shareholders.
- As a result of the close coordination between the Board members and the Board of Supervisors, the BOD has provided valuable feedbacks to GD and the Board of Management, aiming to continuously improve the effectiveness of the company's control and management systems
- The BOD has discussed and approved decisions through Resolutions/Decisions after each meeting and/or obtained the written opinions of Board members on relevant matters, providing GD and the BOM to implement.

### \* Supervisory results:

In the context of strategic competition between major countries, prolonged war conflicts; slow global economic growth; inflation remains high; many countries maintain tight monetary policies, high interest rates; global public debt increases sharply; import and export activities are narrowed; energy security, food security, and cyber security face many challenges, the domestic economy is affected by many unfavorable external factors and internal limitations and shortcomings, hence competitiveness and resilience are limited; the disbursement rate of public investment capital is still slow... production and business activities face many difficulties (especially for processing and manufacturing enterprises), the situation of lack of purchasing orders is common; The purchasing power of the whole market (international and domestic) has decreased. Regarding the wood industry: the export turnover of wood and forestry products has decreased, the export price of wood chips has fluctuated... causing many difficulties in production, business, import and export activities of Vietnames enterprises in general and of Vinafor in particular. In 2024, Typhoon Yagi caused huge damage to the plantations of Vinafor's northern member units.

However, the BOD and the BOM have directed member units to effectively implement solutions to overcome difficulties and strive to complete the production and business plan assigned by the 2024 General Meeting of Shareholders. The expected results are to exceed many targets of the parent company's plan of 2024.

- GD and the BOM have basically fulfilled their roles in managing the production and business activities of Vinafor in accordance with the goals, orientations and

directions of the Board of Directors

- During the management process, GD and the BOM have complied with the decentralization of management of the Charter, the internal regulations of Vinafor as well as the Resolutions, Decisions and directions of the BOD
- Some long-term tasks (complex and difficult tasks that need to be carefully studied) assigned by the BOD, GD is implementing
- Results of implementing recommendations of the State Audit and Government Inspectorate of Vietnam: Vinafor has seriously implemented recommendations of the State Audit and Government Inspectorate and reported in accordance with regulations.
