3. Supervisory Activities of the Board of Directors over the Executive Board

- The BOD supervises the activities of the Executive Board and the Corporation's management officers through regular and irregular BOM meetings, monthly briefing meetings of the Corporation and its Subsidiaries, Divisions, meetings and working sessions with its Subsidiaries, and the reporting system (Financial reports, production and business activity reports, inspection and supervision reports, and performance evaluation reports of the Parent Company and its Subsidiaries).
- The BOD organizes direct and online working sessions on specialized topics, projects, important tasks, and issues deemed necessary by the BOD with authorized personnel of the Corporation, its Subsidiaries, associated companies, and joint ventures, to promptly direct matters within their authority, ensuring all activities throughout the Corporation comply with laws and the Resolutions issued by the GMS and BOD.
- The BOD has directed and developed the Corporation's 2025 Action Program to implement its tasks, disseminating it to all departments, staff, and employees; decisively

and promptly executing key tasks and solutions; focusing resources, accelerating work, progress, investment capital disbursement, and investment portfolio management, promoting the Corporation's key investment projects, resolving difficulties and obstacles to process investment procedures, ensuring project progress as planned, and effective and sustainable investment activities; promptly addressing difficulties and obstacles of the Corporation and its Subsidiaries to mobilize all resources for production and business development.

- The BOD has directed the highest focus and attention to risk management in production and business, investment, and other activities; ensuring security, safety, and environmental protection; preserving and developing state capital in the enterprise; and complying with current laws and regulations.
- The BOD has directed the completion of the 5-year Plan for the 2026-2030 period and the Corporation's Development Strategy until 2030, with a vision to 2050; implementing scientific and technological development, innovation, and digital transformation, creating new momentum, enhancing labor productivity, and competitiveness to achieve double-digit growth.
- In addition, to enhance effective supporting tools for supervision, the Board of Directors has decisively directed the regular review, development, and improvement of relevant internal management regulations, in compliance with State regulations, the Enterprise Law, the Securities Law, corporate governance practices, and the Company's production and business activities.

4. Activities of the Board of Directors' Sub-committees

- Based on the assignment of duties within the Board of Directors, tasks falling under the functions of the Sub-committees, as stipulated, are assigned to individual Board Members according to specific areas and tasks, and they provide opinions on each matter when the Board of Directors needs to consider and decide on issues within its authority.
- In April 2025, the Board of Directors approved the 2025 Internal Audit Plan based on the proposal from the Company's Head of Internal Audit, enabling the Internal Audit Department to carry out internal audit work in 2025, in compliance with the Internal Audit Regulations, relevant internal audit provisions, and current regulations.
- The Company Secretariat is responsible for assisting the Board of Directors with key functions such as advising on corporate governance; managing and handling General Secretarial affairs, assisting the Board of Directors and the Supervisory Board; developing plans and coordinating the organization of PTSC General Meeting of Shareholders in compliance with current legal regulations; managing shareholder, investor, and public relations (IR), and the Board of Directors' internal control.

3. Supervisory Activities of the BoS over the Board of Directors and Board of Management

Based on the rights and responsibilities of the Supervisory Board as stipulated by the Enterprise Law, the Company Charter, the Supervisory Board's Operating Regulations, and in execution of the 2025 inspection and supervision work plan, the BoS conducted inspection and supervision of the Company's production and business operations and financial management during the first 6 months of 2025 according to the following contents.

- Appraise the 2024 Financial Statements, the Report on production and business activities, and the Report evaluating the management work of the Board of Directors in the first 6 months of 2025, and prepare a Report to be submitted to the 2025 Annual General Meeting of Shareholders.

- Supervise compliance with legal regulations, the Company Charter, and the implementation of Regulations, Resolutions, and Decisions of the Annual and Extraordinary General Meetings of Shareholders and the Board of Directors.
- Inspect and supervise the implementation of production and business activities; the implementation status, progress, and effectiveness of investment projects, and the Company's bidding and procurement activities.
- Appraise quarterly and annual Financial Statements. Evaluate operational efficiency and debt repayment capability, capital management and utilization, and the preservation and development of owner's equity.
- Oversee capital balancing and cash flow management; oversee capital mobilization and utilization, and evaluate the efficiency of capital utilization of the Corporation.
