8. **Explanation of second quarter of 2025 business results:**

In Q2 2025, the parent company's revenue decreased compared to the same period in 2024, primarily due to most projects being in the implementation phase and not yet generating revenue. Consequently, revenue remained low, while expenses continued to be incurred, resulting in a negative business performance for Q2 2025. Revenue for Q2 2025 reached 70,681 million VND, a 199% increase from Q2 2024, with an after-tax loss of 1,898 million VND. (Q2 2024 profit after-tax was negative 6,850 million VND).

The subsidiary, Smart Technology Investment and Development Joint Stock Company, has not yet recorded revenue from new products and services. Although its revenue in Q2 2025 increased compared to Q2 2024, it remained modest. The subsidiary's revenue for Q2 2025 was 18,648 million VND, up 307% from Q2 2024, with an after-tax loss of 2,429 million VND. (Q2 2024 profit after-tax was negative 898 million VND).

On a consolidated basis, the company's revenue in Q2 2025 amounted to 89,161 million VND, a 215% increase compared to Q2 2024, consolidated profit after-tax was negative 2,586 million VND. (Q2 2024 profit after-tax was negative 6,818 million VND).
