Pursuant to the Review Report on the semi-annual Financial Statements for 2025, prepared on August 4, 2025, by Viet Standard Audit and Consulting Company Limited, Ben Tre Water Supply and Sewerage Joint Stock Company would like to provide an explanation for the variance of 10% or more in the profit after corporate income tax on the Income Statement of the reviewed semi-annual Financial Statements for 2025 compared to the reviewed semi-annual Financial Statements for 2024, as follows:

- _ Profit after tax of the reviewed semi-annual FS 2025 is: 29,813,637,624 VND
- _ Profit after tax of the reviewed semi-annual FS 2024 is: 35,852,297,674 VND
- _ Decrease difference is: 6,038,660,050 VND

* Reason for difference:

Due to the less severe saltwater intrusion and prolonged heat in the company's water supply area in the first six months of 2025 compared to the first six months of 2024, the water consumption volume in the first six months of 2025 decreased by 464,604 m³ compared to the same period in 2024, leading to a decrease in tap water revenue by VND 5.28 billion. Concurrently, an increase in certain expenses such as salaries, depreciation, and materials for meter connections also contributed to a more than 10% decrease in both pre-tax profit and after-tax profit for the first six months of 2025 compared to the first six months of 2024.
