**Re: Termination of operations of the Banknotes & Vaults Management
Center of Southern Vietnam**

Based on the Charter on the Organization and Operation of the Joint Stock Commercial Bank for Investment and Development of Vietnam;

Pursuant to Circular No. 61/2025/TT-NHNN dated 31/12/2025 of the Governor of the State Bank of Vietnam regulating the operational network of commercial banks;

Pursuant to Decision No. 663/QĐ-BIDV dated 11/06/2025 of the BIDV Board of Directors on the decentralization of authority in business plan management and network;

Pursuant to Resolution No. 564/NQ-BIDV dated 27/05/2026 on approving the name of the Southern Cash Services Branch and termination of operations of the Banknotes & Vaults Management Center of Southern Vietnam;

At the proposal of the Director of the Planning Department.

DECISION:

Article 1. Terminate the operation of the public service unit under the Joint Stock Commercial Bank for Investment and Development of Vietnam (BIDV) as follows:

1. Terminate the operation of the Banknotes & Vaults Management Center of Southern Vietnam:

- Full name: Joint Stock Commercial Bank for Investment and Development of Vietnam – Banknotes & Vaults Management Center of Southern Vietnam

- Abbreviated name: Banknotes & Vaults Management Center of Southern Vietnam.

- Headquarters location: No. 9 Vo Van Tan, Xuan Hoa Ward, Ho Chi Minh City

2. Terminate the operation of the Thu Duc City Transfer Point under the Banknotes & Vaults Management Center of Southern Vietnam:

- Name: Thu Duc City Transfer Point

- Address: No. 650-652-652A Vo Nguyen Giap Street, Phuoc Long Ward, Ho Chi Minh City.

Article 2. Assign Southern Cash Services Branch to implement the following contents:

1. The Southern Cash Services Branch shall fully perform legal procedures, reporting, and information disclosure as prescribed in Circular No. 61/2025/TT-NHNN dated 31/12/2025 and related legal regulations.

2. The Southern Cash Services Branch shall receive and resolve matters regarding the rights, obligations, and responsibilities of the Banknotes & Vaults Management Center of Southern Vietnam according to the regulations of the Joint Stock Commercial Bank for Investment and Development of Vietnam, the State Bank of Vietnam, and the law.

Article 3. This Decision shall take effect from the date of signing.
