The Power Engineering Consulting Joint Stock Company 1 (PECC1), having its head office at 66 Luong Ngoc Quyen Street, Thanh Liet Ward, Hanoi City, holds the Enterprise Registration Certificate No. 0100100953 issued by the Hanoi Department of Finance, amended for the 15<sup>th</sup> time on July 10, 2025.

The Management Board of the Company conducted the collection of shareholders' written opinion forms to approve the Resolution of the General Meeting of Shareholders regarding the data correction as given below:
