Obtaining written opinions from Shareholders On Formula for calculating the number of shares allocated to each participant in ESOP Plan of ABBANK

I. BUSINESS INFORMATION

1. Business Name: An Binh Commercial Joint Stock Bank.

The first Establishment and Operation License No. 0031/NH-GP dated April 15, 1993, re-issued License No. 120/GP-NHNN dated December 12, 2018 of the State Bank of Vietnam and Decisions of the State Bank on amending and supplementing License No. 120/GP-NHNN.

III. PURPOSE, CONTENT OF VOTING AND VOTING RESULTS

1. Purpose of obtaining written opinions from Shareholders:

Approving the Resolution of the General Meeting of Shareholders (GMS) on the Formula for calculating the number of shares allocated to each participant in the share issuance under the Employee Stock Ownership Plan (ESOP) of ABBANK.

2. Contents to obtain written opinions from Shareholders:

The formula for calculating the number of shares allocated to each participant in the ESOP. Detailed information is provided in the Proposal to GMS No.: 39/TT-HDQT.25 dated December 22, 2025, the draft Resolution of the GMS, and the Announcement for obtaining opinions from Shareholders No.: 39/TB-HDQT.25 dated December 23, 2025 of the BOD - Documents are published on ABBANK's website at: www.abbank.vn.

3. Summary and classification of the number of shareholders voted

- a) Total number of shareholders of ABBANK 22,677 Shareholders, owning total charter capital of VND10,350,367,620,000 corresponding to 1,035,036,762 common shares.
- b) Number of Shareholders participated in voting with the number of Voting Slips ABBANK received is: 122 Voting Slips, representing 797,682,123 shares. In which, shareholders exercised their voting rights:
 - By email: 29 Voting Slips.
 - By directly handing over or by mailing: 93 Voting Slips.
- c) Classification of Voting Slips receipt:
 - Number of valid Voting Slips: 121 Voting Slips, representing 797,642,123 shares.
 - Number of invalid Voting Slips: 1 Voting Slips, representing 40,000 shares.

4. Voting results

- a) Total number of Shareholders choosed AGREE: 117 Voting Slips representing 796,150,551 voting shares, accounting for 76.92% of the total number of shares of all Shareholders of ABBANK.
- b) Total number of Shareholders choosed DISAGREE: 02 Voting Slips representing 1,415,010 voting shares, accounting for 0.137% of the total number of shares of all Shareholders of ABBANK.
- c) Total number of shareholders choosed ABSTENTION: 02 Voting Slips representing 76,562 voting shares, accounting for 0.007% of the total number of shares of all Shareholders of ABBANK.

5. Content approved by the GMS

- Pursuant to Clause 4, Article 67 of the Law on Credit Institutions; Article 3 and Article 148 of the Law on Enterprises, Article 47 of ABBANK's Charter;




