3. Supervisory activities of the BOD over the Executive Board (EB) in 2024:

The BOD regularly supervised the implementation of the business production plan and required the EB to report on the results of implementation on a quarterly basis. The BOD held regular meetings once every quarter and invited the EB members to attend, report on the progress of the plan, and propose solutions to improve business performance.

Additionally, every month, the EB held meetings with the managers (heads) of the functional departments to assess the progress of the business production plan, address any outstanding issues or challenges the departments were facing, and provided written reports to the BOD on the completion of key tasks for the month, along with plans for the next month's key tasks. This ensured that the BOD's management and supervision of the EB are more thorough.

The BOD consistently urged the EB to comply with reporting and information disclosure requirements in accordance with current legal regulations.

VI. Corporate Governance Training
