**HEREBY DECIDES:**

**Article 1.** To accept Mr. Tran Anh Tuan, General Director of Vicem Tam Diep Cement Company, to commence his assignment at Vicem But Son Cement Joint Stock Company and appoint him to hold the position of General Director of Vicem But Son Cement Joint Stock Company.

The appointment term shall be 05 years, commencing from May 05, 2026 and not exceeding the expiration of the 2026-2031 term of office of the Company's Board of Directors.

**Article 2.** Mr. Tran Anh Tuan shall be responsible for taking over the handover of work, assets, records, documents and other relevant matters of Vicem





But Son Cement Joint Stock Company in accordance with the applicable regulations.

The salary serving as the basis for payment of social insurance, health insurance and unemployment insurance for Mr. Tran Anh Tuan shall be fixed at VND 29,473,990, salary coefficient 6.64, Step 1, salary group QL001 under the salary scale and payroll system promulgated together with Decision No. 883/BTS-HDQT dated May 29, 2020 of Vicem But Son Cement Joint Stock Company. The position salary and other entitlements of Mr. Tran Anh Tuan shall be implemented in accordance with the Company's regulations and the provisions of the State.

**Article 3.** This Decision shall take effect from May 05, 2026.
