## RESOLUTION

Based on the voting results of the members of the Board of Directors of Vinaship regarding the approval and authorization for the General Director of Vinaship to sign contracts with subsidiaries, affiliates, and related parties, via the form of collecting written opinions under Document No. 752/VNS-HĐQT dated December 30, 2025;

## RESOLVES

**Article 1.** To approve and authorize the General Director of Vinaship to sign contracts between Vinaship and its subsidiaries, affiliates, and related parties with a value of less than 35% of the total asset value of Vinaship according to the latest financial statements; specifically as follows:

1. To sign supply contracts for fleet operations and business activities between Vinaship and companies in which Vietnam Maritime Corporation - JSC and Vietnam Container Shipping Joint Stock Corporation hold shares or contributed capital (List of companies attached).

2. To sign service contracts and office/headquarters lease agreements with Vinaship Maritime Service Co., Ltd (Vimaser).

3. Authorization period: Until December 31, 2026.

**Article 2.** This Resolution shall take effect from the date of signing.



**Article 3.** Members of the Board of Directors, the Board of Management, and the advisory and assisting departments of Vinaship are responsible for the implementation of this Resolution./.
