Ho Chi Minh City Infrastructure Investment Joint Stock Company (“CII”) hereby announces to its shareholders:

On June 5<sup>th</sup>, 2026, CII group disclosed information regarding it becoming a major shareholder of PC1 Group Joint Stock Company (“PC1”) and completed the relevant transaction reporting procedures in accordance with applicable regulations.

In relation to this investment, CII would like to provide the following information to its shareholders:

- The decision to invest in PC1 is based on PC1’s ownership of a portfolio of operating energy projects (including solar power projects benefiting from FIT pricing mechanisms), as well as energy projects expected to commence operation in the near future. This is an essential infrastructure sector that aligns with the long-term development trend of the energy industry and the continuously increasing electricity



demand of the economy. At the same time, this is also an infrastructure segment in which CII has not yet established a presence and has sought investment opportunities over recent years.

- CII affirms that its investment in PC1 is **purely a financial investment**. CII has no intention of participating in the management, operation, or governance activities of PC1, including but not limited to nominating or proposing candidates for election to the Board of Directors or the Supervisory Board of PC1.
