On July 02, 2026, Ben Thanh Water Supply Joint Stock Company received Decision No. 4144/QD-KPHQ dated June 25, 2026, from the Ho Chi Minh City Tax Department regarding the enforcement of remedial measures.

Complying with regulations on information disclosure on the stock market, Ben Thanh Water Supply Joint Stock Company hereby discloses information regarding the above-mentioned Decision as follows:

- Reason: The Decision was issued by the tax authority based on the results of an inspection of the Company's compliance with tax laws for the tax periods from 2016 to 2020, which determined that the Company had certain tax declaration contents that were inconsistent with the provisions of tax laws.

- Main contents of the Decision:

Total amount of tax arrears and late payment interest: VND 8,022,178,266, of which:

+ Collection of tax arrears to the state budget: VND 4,217,096,881;

+ Late payment interest on tax: VND 3,805,081,385;

Simultaneously, a downward adjustment of the remaining deductible value-added tax carried forward to the next period: VND 1,246,225,753.

- Remedial measures: The Company strictly complies with the tax authority's Decision, fully discharging obligations according to the contents of the Decision; simultaneously, continuing to review and improve tax management, and strengthening internal control to enhance the effectiveness of compliance with tax laws.
