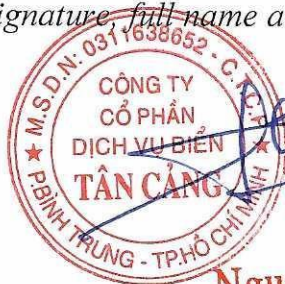
10. Rounding method and handling of fractional shares: The number of shares each shareholder is entitled to receive upon issuance of shares to increase charter capital from equity shall be rounded down to the nearest whole number. Fractional shares (decimal portion) (if any) shall be cancelled and not issued.

*Example: Shareholder A owns 123 shares, Shareholder A is entitled to receive  $123 \times (30,000,319/44,999,681) = 82.001453163$  shares. The number of new shares Shareholder A is entitled to receive, applying the round-down principle, is 82 shares. The fractional portion of 0.001453163 shares shall be cancelled and not issued.*
