Profit after CIT on the parent company's financial statements and consolidation differed by over 10% over the same period last year, due to the fact that during the period, the company promoted the sale of inventory and recorded the handover of apartments at the Aqua Park Bac Giang project, leading to the difference in profit after tax in Q1/2025 compared to the same period last year on the parent and consolidate.

#### - Explanation of after-tax profit in the reporting period with losses:

Revenue from sales and provision of services in Q1 of 2025 will increase significantly compared to the previous quarter, however, Revenue from financial activities decreased and Financial expenses increased, resulting in a loss in profit after corporate income tax on separate and consolidated financial statements.
