The General Meeting proceeded to elect 01 member to the Board of Supervisors of Thai Nguyen Iron and Steel Joint Stock Corporation for the 2024-2029 term in accordance with Clause 3, Article 148 of the Law on Enterprise in 2020 and Clause 3, Article 28 of the Corporation's Charter and the Regulations for supplementary election and replacement of members of the Board of Directors and Board of Supervisors of Thai Nguyen Iron and Steel Joint Stock Corporation for the 2024-2029 term at the Annual General Meeting of Shareholders 2025. The election was conducted using the cumulative voting method with secret ballots at the meeting.

The Vote Counting Committee proceeded to print and distribute ballots, providing voting instructions.
