- Based on Circular No. 96/2020/TT-BTC dated November 16, 2020, of the Ministry of Finance guiding the disclosure of information on the securities market; and Circular No. 68/2024/TT-BTC dated 18 September 2024, amending and supplementing certain provisions of Circular No. 96/2020/TT-BTC.
- Based on the business performance results (on a consolidated and separate basis) in the financial statements for the six-month period ended 30/6/2026 and 30/6/2025.

Masan Group Corporation (“MSN” or “Company” or “Group”) would like to explain the fluctuations in profit after corporate income tax on a consolidated and separate basis for the six-month period ended 30/6/2026 and 30/6/2025 as follows:

The net profit after corporate income tax (on a consolidated basis) of the Group in 1H2026 was VND 5,773 billion, an increase of 122% compared to the same period last year of VND 2,602 billion mainly due to the following factors:

- Increase in revenue (from VND 37,212 billion in 1H2025 to VND 52,137 billion in 1H2026) and gross margin (from VND 11,884 billion in 1H2025 to VND 16,817 billion in 1H2026) of 40% and 42% respectively was primarily driven by strong revenue growth momentum and improved operating profit margins across all consumer-retail business segments, as well as the recovery of the high-tech materials segment;
- Increase in share of profit in associates by 16% mainly due to better performance from these entities during 1H2026, from VND 2,431 billion in 1H2025 to VND 2,817 billion in 1H2026.



Difference in profit after corporate income tax on a separate basis compared to the same period last year

The company's profit after corporate income tax for the six-month period ended 30/6/2026 was VND 349 billion, while in the same period last year the company made a loss of VND 317 billion, mainly due to in Q2/2026, the Company recognised a dividend income of VND734 billion from an associate while in 2025, the Company received a similar dividend from that associate in Q4/2025.
