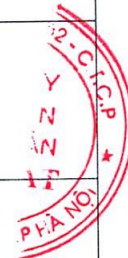

- Organizations and individuals that in relation to other organizations or individuals directly or indirectly control or are controlled by such organizations or individuals or together with such organizations or individuals under the same control;
- Individuals and natural fathers, natural mothers, adoptive fathers, adoptive mothers, fathers-in-law, mothers-in-law, fathers-in-law, mothers-in-law, wives, husbands, natural children, adopted children, daughters-in-law, sons-in-law, brothers-in-law, sister-in-law, sister-in-law, brothers-in-law, brothers-in-law, sisters-in-law of such individuals;
- Securities investment fund management companies and securities investment funds and securities investment companies managed by such securities investment fund management companies;
- Contractual relationships in which one organization or individual is the representative of the other organization or individual;
