SONG BAHA 1.* Standards for nominated and self-nominated candidates for Member of the Board of Supervisors:

Referring to Clause 2, Article 37 of the Company's Charter, the conditions and standards for Members of the Board of Supervisors must comply with the provisions in Article 169 of the Law on Enterprises No. 59/2020/QH14, specifically as follows:

- + Not subject to the provisions in Clause 2, Article 17 of the Law on Enterprises No. 59/2020/QH14;
- + Trained in one of the following majors: economics, finance, accounting, auditing, law, business administration, or a major suitable for the Company's business activities;
- + Not a family member of a Member of the Board of Directors, General Director, and other managers;
- + Not a manager of the Company; not necessarily a shareholder or employee of the Company;
- + Members of the Board of Supervisors of public companies and state-owned enterprises as stipulated in Point b, Clause 1, Article 88 of the Law on Enterprises No. 59/2020/QH14 must not be a family member of the enterprise's managers of the Company and the Parent Company; Capital Representatives of the enterprise, Capital Representatives of state capital in the Parent Company and in the Company.
 - Members of the Board of Supervisors shall not fall into the following cases:
 - + Working in the accounting or finance department of the Company;
- + Being a member or employee of an independent auditing firm that audited the Company's financial statements in the immediately preceding 03 (three) years.
- 2. Conditions for nomination and self-nomination for Member of the Board of Supervisors:

Referring to Article 36 of the Company's Charter on organization and operation, the conditions for Shareholders, groups of Shareholders to nominate, self-nominate members of the Board of Supervisors are as follows:

Shareholders holding common shares have the right to aggregate their voting rights to nominate candidates for Member of the Board of Supervisors. Shareholders or groups of shareholders holding from 10% to less than 20% of the total voting shares may nominate 01 (one) candidate, from 20% to less than 30% may nominate a maximum of 02 (two) candidates, from 30% to less than 40% may nominate a maximum of 03 (three) candidates, from 40% to less than 50% may nominate a maximum of 04 (four) candidates, from 50% to less than 60% may nominate a maximum of 05 (five) candidates, from 60% to less than 70% may nominate a maximum of 06 (six) candidates, from 70% to less than 80% may nominate a maximum of 07 (seven) candidates, from 80% to less than 90% may nominate a maximum of 08 (eight) candidates, and from 90% or more may nominate 09 (nine) candidates.

In case the number of candidates for Member of the Board of Supervisors through nomination and self-nomination is insufficient, the incumbent Board of Supervisors may nominate additional candidates or organize nominations in accordance with the Company's Charter, the Regulations on Corporate Governance, and the Regulations on Operation of the Board of Supervisors. The introduction of additional candidates by the incumbent Board of Supervisors must be clearly announced before the General Meeting of Shareholders votes to elect members of the Board of Supervisors in accordance with

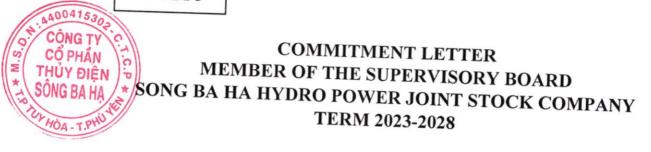
