RESOLUTION

Re.: Approval of the Results of the Public Offering of Convertible Bonds of Thanh Thanh Cong – Bien Hoa Joint Stock Company (the “Bonds”)

THE BOARD OF DIRECTORS

THANH THANH CONG - BIEN HOA JOINT STOCK COMPANY (the “Company”)

- Pursuant to the Law on Securities No. 54/2019/QH14 adopted by the National Assembly of the Socialist Republic of Vietnam on November 26, 2019 (as amended and supplemented from time to time), and guiding documents (“Law on Securities”);
- Pursuant to Decree No. 155/2020/ND-CP dated December 31, 2020 of the Government providing detailed guidance on a number of articles of the Law on Securities (“Decree 155”);
- Pursuant to Decree No. 245/2025/ND-CP dated September 11, 2025 of the Government amending and supplementing a number of articles of Decree 155 (“Decree 245”);
- Pursuant to Circular No. 118/2020/TT-BTC dated December 31, 2020 guiding certain contents on securities offering, issuance, public tender offers, share repurchase, registration and deregistration of public companies (“Circular 118”);
- Pursuant to Circular No. 115/2025/TT-BTC dated December 15, 2025 amending and supplementing a number of articles of Circular 118 (“Circular 115”);
- Pursuant to the Charter of Organization and Operation of Thanh Thanh Cong – Bien Hoa Joint Stock Company (“Charter”);
- Pursuant to Resolution No. 10/2025/NQ-DHDCĐ dated December 6, 2025 of the General Meeting of Shareholders approving the plan for public offering of convertible bonds of the Company (“Resolution No. 10”);
- Pursuant to Resolution No. 37/2025/NQ-HDQT dated December 29, 2025 of the Board of Directors approving the detailed issuance plan and the plan for use of proceeds from the public offering of convertible bonds (“Resolution No. 37”);
- Pursuant to the Certificate of Registration for Public Bond Offering No. 50/GCN-UBCK issued by the Chairman of the State Securities Commission on March 19, 2026;
- Based on the bank confirmation of the escrow account balance opened at Vietnam Joint Stock Commercial Bank for Industry and Trade
- Pursuant to the Minutes of Meeting of the Board of Directors No. 61/2026/BBH-HDQT dated Jun 11, 2026.



RESOLVE

Article 1. Approval of the Results of the Public Offering:

Approval of the results of the public offering of convertible bonds of Thanh Thanh Cong – Bien Hoa Joint Stock Company (Bond Code: SBT426001), as follows:

- a) **Total number of bonds offered:** 9,999,995 bonds (Nine million nine hundred ninety-nine thousand nine hundred ninety-five bonds)
- b) **Offering price:** VND 100,000 (One hundred thousand Vietnamese Dong) per bond
- c) **Total number of bonds distributed:** 9,971,053 bonds, equivalent to 99.71% of the total bonds offered
- d) **Total proceeds from the offering:** VND 997,105,300,000 (*)

() The total proceeds from the bond offering amount to VND 997,105,300,000. However, according to the confirmation from the bank where the escrow account is opened, the actual credited amount to the escrow account, after VSDC automatically deducted a transfer fee of VND 1,100,000, is VND 997,104,200,000.*

*(**) This amount arose from an internal transfer error of the Issuer and was recorded in the escrow account for bond subscription proceeds. The Issuer confirms that this amount does not represent proceeds from investors subscribing for bonds and is considered an excess payment, which does not affect the bond distribution results. Upon release of the escrow account in accordance with regulations, the Issuer shall transfer this amount to its operating account in compliance with applicable laws.*

Article 2. Authorization

The Board of Directors of Thanh Thanh Cong – Bien Hoa Joint Stock Company hereby authorizes and delegates the Chairman of the Board of Directors, or the Chief Executive Officer, or Mr. Tran Quoc Thao – Deputy Chief Executive Officer, to:

- Direct and implement the reporting of the results of the public offering of convertible bonds (Bond Code: SBT426001) to the competent regulatory authorities; and
- Carry out all necessary procedures for bond registration with the Vietnam Securities Depository and Clearing Corporation (VSDC), and for listing the bonds on the Hanoi Stock Exchange (HNX) in accordance with applicable laws

Article 3. Effectiveness

This Resolution shall take effect from the date of signing.

Members of the Board of Directors, the Management, and relevant individuals and departments of Thanh Thanh Cong – Bien Hoa Joint Stock Company shall be responsible for the implementation of this Resolution.
