1.1.Name (unchanged):

1.2. Location:

2. LPBank and LPBank Ho Chi Minh City branch shall be responsible for:

2.1. Ensuring accuracy and truthfulness and taking full responsibility for the serious and complete implementation of all contents reported and committed in Official Letter No.5258/2026/LPBank.CMD dated February 10th, 2026.

2.2. Report and disclose the change in accordance with Clause 6, Article 19, Article 23 of Circular No. 32/2024/TT-NHNN dated June 30th, 2024 from the Governor of the State Bank of Vietnam on the operation network of commercial banks.

2.3. Organize safe operations and assume responsibility for all risks of the transaction office, focus on convenience and safety for transactions and assets, ensure a complete security system, protection



of power supply, continuous communication, and compliance with fire prevention and safety requirements.
