The State Securities Commission (SSC) received the dossier of notification of the maximum foreign ownership ratio (SHNN) No. 59A/2026/TB-VE9 dated June 24, 2026 of VNECO 9 Investment and Construction Joint Stock Company (the Company) (UPCOM: VE9) at 0%, the SSC has the following opinions:

1. Organizations and individuals participating in the dossier preparation process shall be responsible before law for the legality, accuracy, truthfulness and completeness of the dossier as prescribed in Clause 1, Article 11a of the Law on Securities No. 54/2019/QH14 as amended and supplemented by Law No. 56/2024/QH15 and take responsibility for the results of reviewing the maximum SHNN ratio at the Company in accordance with the law. In case the Company has the current SHNN ratio exceeding the SHNN ratio as prescribed by law, the Company needs to comply with the provisions of Clause 5, Article 139 of Decree No. 155/2020/ND-CP detailing the implementation of a number of articles of the Securities Law amended and supplemented by Decree No. 245/2025/ND-CP.

The SSC requests the Company to fulfill the obligation to disclose information as prescribed in Clause 2, Article 13 of Circular No. 96/2020/TT-BTC guiding the disclosure of information on the securities market as amended and supplemented by Circular No. 68/2024/TT-BTC, Circular No. 18/2025/TT-BTC and comply with the provisions of law on the ratio of SHNN on the Vietnamese stock market.

3. The Vietnam Securities Depository and Clearing Corporation shall update and adjust on the system the maximum SHNN ratio at the Company as prescribed in Clause 4, Article 142 of Decree No. 155/2020/ND-CP amended and supplemented by Decree No. 245/2025/ND-CP.

The SSC notifies the Company, the Vietnam Securities Depository and Clearing Corporation and related units to know and comply with regulations./.
