2. Disclosed information:

According to the list of shareholders owning securities established by the Vietnam Securities Depository and Clearing Corporation – Ho Chi Minh City Branch on January 22, 2026, there are 304 shareholders, including:

- The largest shareholder is the People's Committee of Ben Tre Province (now the People's Committee of Vinh Long Province), holding 64% of the charter capital (equivalent to 18,816,000 shares).

- Thuy Anh Water Supply Sewerage Joint Stock Company holds 17.38% of the charter capital (equivalent to 5,109,510 shares).

- Hoan Cau Company Limited holds 15% of the charter capital (equivalent to 4,410,000 shares).

- 301 other shareholders hold 3.62% of the charter capital (equivalent to 1,064,490 shares).

Therefore, Ben Tre Water Supply and Sewerage Joint Stock Company does not meet the conditions of a public company as stipulated in Point a, Clause 1, Article 32 of the Law on Securities No. 54/2019/QH14 dated November 26, 2019, as amended and supplemented at Point a, Clause 11, Article 1 of Law No. 56/2024/QH15 dated November 29, 2024; specifically, the Company does not have at least 10% of voting shares held by at least 100 investors who are not major shareholders.

Pursuant to Decision No. 1479/QĐ-TTg dated November 29, 2022 of the Prime Minister approving the plan for restructuring state-owned enterprises and enterprises with state capital for the period 2022–2025, the State is expected to maintain a 64% ownership stake in Ben Tre Water Supply and Sewerage Joint Stock Company until 2025.

Currently, the People’s Committee of Vinh Long Province and the Prime Minister are considering and deciding on the roadmap for restructuring state capital in the Company in the next phase.
