The Board of Directors held the meeting to approve the following: capital contribution to the associated company within the scope of the capital commitment upon the establishment of the enterprise to implement the dissolution of TNG Yen Binh Golf LLC, specifically:

- 1. In order to implement Resolution No. 14/NQ-HĐQT dated January 8, 2024, of the Board of Directors regarding the dissolution of Yen Binh TNG Golf Limited Liability Company, in order to meet the legal requirements for dissolving Yen Binh TNG Golf Limited Liability Company, the Board of Directors approves the capital contribution to Yen Binh TNG Golf Limited Liability Company within the scope of the committed capital contribution when the company was established as follows:
- Contributed capital: VND 29,400,000 (Twenty-nine million four hundred thousand Vietnam dong)
- Capital contribution conditions: Ensure that TNG Investment and Trade Joint Stock Company's contribution accounts for 49% of the total actual contributed capital of TNG Yen Binh Golf LLC
- 2. Assign and authorize Mr. Nguyen Van Thoi the representative of the entire capital contribution at TNG Yen Binh Golf LLC:
- Represent TNG Investment and Trade Joint Stock Company in negotiating and agreeing with the remaining member of TNG Yen Binh Golf LLC to carry out the capital contribution and dissolution of TNG Yen Binh Golf LLC as per the policy approved by the Board of Directors.
- Attend the meetings of the members' council of TNG Yen Binh Golf LLC, vote in favor of corresponding issues, and carry out the necessary procedures to finalize the capital contribution and dissolution of TNG Yen Binh Golf LLC as per the policy approved by the Board of Directors.
- Member comments during the meeting: No other comments.

- Members in favor: 7/7 attending members, representing 100% of the total votes
- Members against: 0/7 attending members, representing 0% of the total votes
- Members abstained: 0/7 members, representing 0% of the total votes
