1. 2. The SSC has publicly disclosed on its official website the receipt of a complete dossier for registration of the Company’s private placement of shares. The Company’s private placement plan shall be implemented in accordance with the Resolution of the Extraordinary General Meeting of Shareholders (1st meeting in 2025) No. 02/2025/NQ-DHĐCĐ dated October 14th, 2025; the Resolution of the Board of Directors No. 17/2025/NQ-HĐQT dated November 26th, 2025; the Resolution of the Board of Directors No. 18/2025/NQ-HĐQT dated November 26th, 2025; the Resolution of the Board of Directors No. 25/2025/NQ-HĐQT dated December 22nd, 2025; and in compliance with the prevailing laws and regulations.
3. Within ten (10) days from the end date of the offering, the SSC requests that the Company submit a Report on the results of the offering, enclosed with certification from the bank where the escrow account is opened regarding the amount of proceeds collected from the offering, to the SSC, and disclose information on the Company’s website regarding the offering results, in accordance with Clause 4, Article 48 of Decree No. 155/2020/NĐ-CP dated December 31st, 2020 of the Government detailing the implementation of a number of articles of the Law on Securities.
