The annual shareholders meeting 2024 of An Giang Fisheries Import and Export Joint Stock Company began at 8:30 AM, on 21st June 2024, at the company's head office, address: 1234 Tran Hung Dao St., Binh Duc Ward, Long Xuyen City, An Giang province with the attention of shareholders and the authorized shareholders who owned 24,732,651 shares of 28,109,743 shares, rated 87.99% of charter capital.

THE GENERAL MEETING OF SHAREHOLDERS DECIDES

Article 1: To adopt the report of management board and the member of Independent management board in 2023

The Board of Management has proposed many solutions to help the Company overcome the difficult period such as: solutions to reduce production costs from input raw materials to processing and exporting to stabilize revenue, profit and income for employees. However, due to the impacts of the Chinese market (the main export market of processing units), the processing units have to temporarily stop production regularly for a long time, seriously affecting the revenue and operating efficiency of the Company; the impacts of the war between Russia and Ukraine has caused the purchasing power of the European market has decreased sharply, affecting the production activities of the Company.

In addition to the unfavorable business results in many previous years, the accumulated loss of more than 866 billion VND, of those causing banks to tighten the Company's loan capital (Besides that, banks continue to withdraw loans from 5-10%/year), leading to a lack of capital to serve production needs, the farming areas lack capital to farm and have to stop farming while these are farming areas leased from the government, leading to a loss of more than 3 billion VND, forcing the farming areas to be leased to reduce costs. The lack of raw materials for production, having to temporarily stop 03 processing factories, letting other units process is only temporary to maintain the workforce and depreciate machinery and equipment, not enough to cover the financial costs incurred, especially interest, leading to business results not being as good as expected; This is the reason leading to the loss in business results.

Article 2: To adopt the report of Directors board in 2023

- Total revenue in the fiscal year 2023 reached only more than 452 billion VND (of which processing revenue was over 190 billion VND), negative profit of over 6 billion VND, but compared to the previous year's loss of over 19 billion VND, this is a positive result. The main reason for this result is due to the negative business performance in many consecutive years, leading to low line of credit from banks, almost without the capital for production, the market is narrowed, gradually losing traditional customers due to lack of export goods according to customer requirements; The structure of export goods is only concentrated in the Asian, Australian and European markets. The factors leading to unfavorable business results in 2023 are as follows:

* Without raw material to produce actively and supply customers with goods when receive the orders from cuntomers as well as expending to new markets resulting in loss of some customer due to not meet the requirement of the signed contracts.

* The prolonging war between Russian and Ukraine caused the global fuel crisis, high inflationary in many places, the loan interest increased from banks, effecting to the income and consumption of people, they have to reduce spending and buying.

* The Chinese market has many fluctuation. Goods of processing units has been stagnant, low debt conlection, clients squeeze prices, etc...leading to the situation of having to frequently stop production for along time, affecting the company's processing revenue resulting in the company has no efficiency.

* Banks continues to tighten credit, loan packages with low interest are not enough capital for production (but withdraw the loan capital from 5% to 10%) which affected the capital turnover, lack of capital to buy materials for production as well as maintaining the fish source result in lacking of raw material, not enough goods to supply when customers order, finally missing the business opportunity; in that case, the company have to buy the finish products from processing units for exporting to keep the traditional customers, therefore, the business result is break-even or loss.

The shareholders voted to adopt with 90,63% per total of attendence stocks

3. The supervisory activities of the Management Board over the Executive Board.

Successfully organized the annual shareholders meeting 2024. The general director continues to focus on production and business with all attemps; to reorganize the administration and management for resolving difficulties of markets

The general director develops and implements the resolutions of the 2023 annual shareholders meeting and the management board. Reports fully and rapidly to the Management board about business and production situation of the company, and proposes solutions related to development strateries so that the Management board can makes the final decisions, specially:

- The company's factories currently have to lease for processing to maintain the production and to create job for workers, however the turnover is not enough to compensate charges; The Chinese market is not stable, therefore, the processing units must reduce the production below the capacity frequently leading to the turnover was not meet expectation.

- Not enough raw material for processing and supplying customers as receiving orders as well as expanding to new markets. For these reasons, the customers must leave due to not meet the requiment of contracts.

- Banks continues to tighten credit, loan packages are short term with high interests (but withdraw the loan capital from 5% to 10%) not only affecting to the capital turnover, but also being under the hug pressure on maturity leading to the company always lacks of capital for production and trading. Source of export goods is from the processing units to maintain the traditional customers therefore the profit was not as expectation.

 Due to a lack of funding for independent farming, farming areas had to temporarily cease operations and were leased to external organizations and individuals to cover costs, while maintaining only a low farming output in one area eventhough the fish farming efficiently is very positive.
