The profit after tax during the accounting period from July 01<sup>st</sup>, 2025 to September 30<sup>th</sup>, 2025 is 2.844.172.676 VND, increased by 459.470.252 VND, compared to the same period due to the following primarily reasons:

1. Gross profit from sales and service provision decreased by VND 1,018,270,011, mainly due to changes in the product mix. Higher revenue was generated from products with lower profit margins, such as by-products.

2. Financial expenses decreased by VND 1,357,470,091 due to a reduction in loan principal compared to the same period.

3. Other income increased by VND 566,555,558 during the period, mainly due to proceeds from the disposal of fixed assets.

Other items did not have a significant impact on the Company's profit after tax for the accounting period from July 1, 2025 to September 30, 2025, compared with the same period last year.

Overall, the above-mentioned factors resulted in an increase of VND 459,470,272 in profit after tax for the accounting period from July 1, 2025 to September 30, 2025, compared with the same period last year.
