According to the Q3/2025 Financial Statements, the Company's profit after-tax was 6.155 billion VND, a decrease of 10.182 billion VND compared to the same period in 2024. HIPC hereby provides the following explanation:

1. Total revenue in quarter 3/2025 reached 10.115 billion VND, decreased by 21.518 billion VND, equivalent to a decrease of 68% compared to the same period in 2024. Specifically:

Revenue from land re-leasing activities in Q3/2025 reached 1.313 billion VND, a decrease of 6.853 billion VND, equivalent to an 84% decrease compared to the same period in 2024. However, in 2025, HIPC recorded a revenue deduction related to several land lease contracts totalling 19.761 billion VND, resulting in total revenue in quarter 3/2025 decreasing compared to the same period in 2024.

Other revenue (from services such as clean water supply, wastewater treatment, dormitory rental for workers, etc.) in quarter 3/2025 reached 22.641 billion VND, increased by 0.226 billion VND, equivalent to a 1% rise. Financial income reached 5.229 billion VND, decreased by 52% equivalent to a decrease of 4.823 billion VND. Other income reached 0.693 billion VND, an increase of 0.069 billion VND, equivalent to a 11% rise compared to the same period in 2024.

2. Total expenses in Q3/2025 were 2.421 billion VND, a decrease of 12.875 billion VND, equivalent to an 84% decline compared to the same period in 2024. Specifically:

Cost of land sublease operations in Q3/2025 was 1.449 billion VND, down 5.369 billion VND (a decrease of 79%) compared to the same period in 2024. The reason was that in 2024, there was a revenue deduction related to several land lease contracts and a corresponding reversal of cost of goods sold.

Other costs (including costs of water supply services, wastewater treatment, and worker accommodation rentals, etc.) in Q3/2025 were 15.231 billion VND, an increase of 0.466 billion VND, equivalent to a 3% rise compared to the same period in 2024.

Selling expenses, administrative expenses, and other expenses totaled 7.296 billion VND, an increase of 0.936 billion VND, equivalent to a 15% rise compared to the same period in 2024. The increase was due to the reimbursement of green corridor lease payments amounting to 1.534 billion VND.

3. For the above reasons, the Company's profit before tax in Q3/2025 was 7.694 billion VND, a decrease of 8.643 billion VND, equivalent to a 53% decline compared to the same period in 2024.
