- According to 2023 and the 2024 audited financial statement of DNA Investment Joint Stock Company submitted to the State Securities Commission and Ha Noi Stock Exchange.

DNA Investment Joint Stock Company submits a disclosure document with the following explaination:

- 1. Profit after tax in the reporting period has a discrepancy of 5% or more before and after the audit;
- 2. Profit after tax in the statement of profit or loss for the reporting period has variated by 10% or more compared to the same period in the previous year;
- 3. Profit after tax in the reporting period incurred a loss, changing from a profit in the same period last year to a loss in this period:
- For 2023 audited financial statement, the company's profit after tax was 154.364.172 VND.

- For 2024 audited financial statement, the Company's profit after corporation income tax is (713.586.204) VND. Compared to the same period last year, the Company's profit after tax has shifted from a profit to a loss, decreasing by 5.6 times.

Reason:

- During the audit of the 2024 Financial Statements, the Company made an additional provision of VND 1.2 billion and recorded additional audit expenses, resulting in a discrepancy of more than 5% between the pre-audit and post-audit figures.
- Additionally, the net profit from business operations was positive; however, in 2024, the Company carried out the liquidation of certain inefficient machinery and equipment, resulting in a negative other income. Consequently, the after-tax profit for 2024 shifted from a profit in 2023 to a loss, with a discrepancy of over 10%.
