The Company recorded an after-corporate-income-tax profit in the third quarter of 2025, having been in a loss position in the third quarter of 2024. The principal reasons are as follows:

In the Third Quarter of 2025, the stock market showed strong recovery: trading volume increased, and stock prices rose compared to the same period in



the prior year. As a result, revenue from proprietary trading also increased. Moreover, the rise in stock prices led to higher revaluation gains on financial assets compared to the same period last year. During the quarter, the Company also achieved reductions in financial expenses and general & administrative expenses. These are the main reasons why the business results for the period increased significantly compared to the same period last year.
