- Total revenue achieved in the reporting period: VND 3,259,579,437
- Total expenses in the reporting period: VND 17,426,140,839

Of which, the interest expense for the construction of the Vung Ang Thermal Power Plant is 14,113,000,043 VND

Thus, the total expenses are greater than the total revenue achieved, leading to the loss in the after-tax profit of the third quarter of 2025 of VND 14,166,561,402.
