Pursuant to Circular No. 96/2020/TT-BTC dated November 16, 2020, of the Ministry of Finance guiding information disclosure on the securities market, Petrolimex Nghe Tinh Transportation and Services Joint Stock Company (the Company) would like to explain the profit fluctuation in the Q1 2025 Financial Statement compared to the same period in 2024 as follows:

Pursuant to the Q1 2025 financial statement of Petrolimex Nghe Tinh Transportation and Services Joint Stock Company, the Company recorded a profit after tax for Q1 2025 of VND 4,110,914,301, an increase of 17% compared to the same period in 2024 (Q1 2024: VND 3,521,997,955). This fluctuation is attributed to the following reasons:

- The Company's transport volume increased compared to the same period, leading to higher profits from the transport business;
- The Company's financial expenses decreased compared to the same period due to the Company's access to low-interest loans, resulting in lower financial costs;
- Additionally, the Company's other income increased due to earnings from leasing space for electric vehicle charging stations.
