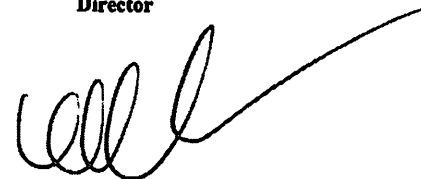

FINANCIAL STATEMENT FOOTNOTES

I. Characteristics of the Company's Operations
