Saigon Water Infrastructure Corporation explains the variance in consolidated business performance for the third quarter of 2025, compared to the same period last year, as follows:

- 1. In the third quarter of 2025, Net profit after corporate income tax increased by a loss approximately 1,89 billion VND compared to the same period last year, primarily due to the following reasons:
 - Financial expenses increased: due to the consolidation of the subsidiary Sài Gòn An Khê Company (starting to recognize the subsidiary from December 2024). This subsidiary has a loan with BIDV Bank.
 - The share of profit or loss from associated companies decreased: since the divestment from Tân Hiệp Company was completed at the end of 2024, it is no longer recognized in Q3 2025
 - Selling expenses increased compared to the same period last year, primarily due to the restructuring of personnel between the sales department and the management department.
 - General and administrative expenses increased compared to the same period last year, mainly due to the allocation of goodwill costs when consolidating the subsidiary Sài Gòn An Khê Company (started recognizing the subsidiary from December 2024).
- 2. The after-tax profit from corporate income tax in Q3 2025 recorded a loss of 5.002.468.082 VND due to revenues and income failing to balance the expenses during the period. Additionally, the SII Company is currently facing challenges with the Ců Chi project, as the output has not yet met expectations, and the loans for the Ců Chi project remain excessively large; details are as follows
